## OFFICE MEMORANDUM

  - (ii) with two years' service in the grade rendered after appointment thereto on regular basis in level 13 A (Rs. 1,31,100 2,16,600/-) in the pay matrix or equivalent in the parent cadre or department; or
  - (iii) with three years' service in the grade rendered after appointment thereto on regular basis in level 13 (Rs. 1,23,100 2,15,900/-) in the pay matrix or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualifications and experience:
  - degree in Civil or Electrical or Mechanical engineering from a recognized university, and
  - (ii) fifteen years' experience in areas of appraisal of feasibility or detailed project report, project financing, project monitoring or quality control of project, including five years' experience in large projects of Mass Transport System.
- 4. Period of deputation including short term contract including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years. The maximum age-limit for appointment by deputation including short-term contract shall be not exceeding fifty-eight years, as on the closing date of receipt of applications.
