- **July 2, 2015** Draft on Housing for All (Urban) Mission-Model Tender document and Guideline is prepared and uploaded for getting State's feedback.
- **July 21, 2015** A team is constituted under Joint Secretary (HFA) and Mission director with total 16 members (Experts from 7 Technical institutes and Secretaries from 6 State Governments) wherein a broad objective, Terms of Reference, draft MoU and list of areas of expertise is identified.
- **July 22, 2015** A draft document is prepared and uploaded at Ministry's website for getting State's feedback-Multi Attribute Evaluation Criteria for Evaluation of Emerging Technologies.
- **August 28, 2015** First meeting of Technology submission members was held to decide Funding norms and major Activities by Technical Institutes at two levels of Regional Technical Institutes (RTI) and State Technical Institutes (STI) and minutes have been issued on dated 15/09/2015
