  - The State shall furnish the Utilization Certificates of the Grant released for the vi. RAY in the prescribed format as per GFR 2017.
  - The funds may be utilized for the purpose for which they are given. Otherwise vii. they will have to be refunded along with interest as per provisions for GFR 2017.
  - Where there is an element of cash transfer, the same may be made through viii. PFMS/DBT mode as applicable.
- Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
- The payment is adjustable from the account of the Central Government in the books under the following Head of Account under Demand No. 56 of Ministry of Housing and

Urban Affairs for the year **2019-20** after duly re-appropriation from the respective Nonfunctional Head to the Functional Head for NE States:
