- **Vision for CSP (With respect to management of liquid and solid waste)**

Vision is to make the city clean and free from all waste hazards

- **How do you propose to integrate new/ongoing/existing projects on sanitation with CSP?**

NP intends to strengthen / revitalize existing sanitation work with help of CSP. Implementation of CSP would generate awareness in the city / all stakeholders regarding proper sanitation. Simultaneously orientation programmes/ training for NP official/ staff , elected representatives & all stakeholders will go a long way in changing the age old mindset about sanitation. NP with help of CSP shall also gear up/ alter its approach towards sanitation with the ultimate aim of keeping city clean & garbage free.

- **Plans for stakeholders participation- NGOs, Media, citizens etc.**

Process has started & as already mentioned participation of all stakeholders, NGOs, media & citizens with emphasis on household ladies will now be taken in a formal way in this month.

ULB to utilize funds provided as per the details/ steps mentioned in the plan submitted at GoI and as per the instructions given in work order. Process will be completed as per the sanctioned schedule.

Short term goals have been mentioned above as training to all the stakeholders, campaigns etc. to solve the existing city sanitation problems.

Long term goals – this will include transforming the mindset / attitude of people at large about sanitation issues, to make sanitation the first priority of the ULB so as to ultimately achieve the goal of NUSP 2008 of making the city clean hygienic and free from all kind of hazards .

- **Sustainability plan.... Cost recovery?**

Once the worthiness of ULB vis a vis sanitation works starts establishing among the people & ULB starts moving in the direction of providing safe & hygienic environment , people would be automatically willing to pay user charges. ULB plans to collect user charges against the services provided in different slabs as per the economic status of the payer

Workshops planned after sanctioning of CSP and 5 have been organized which included all possible stakeholders

Training/orientation at ULB level for elected representatives and sanitation staff is underway through NP & Directorate Officials. Shortly local NGOs to be involved to impart training. Gradually as the concept get expands, NP intends to engage UAA, Nanital for specialized training
