I am directed to convey the sanction of the Competent Authority to the release of Rs. 16,96,000/- (Rupees Sixteen Lakh and Ninety Six Thousand only) as 2nd and final instalment (25%) of Central Assistance to State Govt. of Arunachal Pradesh for preparation of HFAPoAs for 29 towns under Pradhan Mantri Awas Yojana (Urban) {PMAY(U)} Mission for FY 2019-20. The details of towns/cities for which 2nd and final installment for HFAPoAs is being released are enclosed at **Annexure**.

- 2. Earlier, the fund of Rs. 137.025 lakh as 1st installment (75%) of Central Assistance for preparation of HFAPoAs for 29 cities was released to State Govt. of Arunachal Pradesh vide sanction letter No.I-12012/2/2016-HFA-V/FTS-15550 dated 03.08.2016 and 21.02.2017. - iii. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- iv. The amount Central Assistance approved will form a part of capacity building plan of the state under PMAY(U) Mission.
