Sir,

I am directed to convey the sanction of the Competent Authority to release an amount of Rs. 35,50,000/- (Rupees Thirty Five Lakh and Fifty Thousand only) as advance payment of 1st installment (50% of admissible Central Assistance) towards IEC activities performed/to be performed by the States of Assam, Meghalaya and Nagaland under Capacity Building Activities of PMAY(U) for FY 2018-19. The State-wise details of release are as under:

- The above grant is subject to the following conditions:
  - i. All IEC activities are allowed except T.V. advertisements and News Paper advertisements. IEC activities are to be carried out in the State based on preapproved Government /DAVP rates. The agencies selected to perform the IEC activities should be empanelled with Government or should have sufficient prior experience of working with Government. All expenditures will be reimbursed as per actuals and based on cost norms against urban population in the States.
- ii. The bills and vouchers regarding the expenditure incurred under IEC are to be examined and approved at the SLNA level by the competent authority as per State rule, as the case may apply (the bills/vouchers to be counter signed by the Finance Department) and an Undertaking and claim of reimbursement to be submitted to the Ministry.

- iii. A brief report highlighting assessment of impact by IEC activities is also required for reimbursement. All bills/vouchers etc. should be safely kept at SLNA level for future audit and other references. All expenditure under this head is to be reimbursed.
- iv. Remaining 50% of Central Assistance would be released as per actual and on receipt of Utilization Certificate along with Undertaking (in prescribed format mentioned in Capacity Building Activities - Norms, fund disbursal processes and Plan Templates) from the States.
- v. PMAY(U) promotion activities should have prominent display of PMAY logo and name, Prominence of PMAY(U) in IEC materials should reflect in content, size, and in all other possible ways.
- vi. The States will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- The States will utilize the sanctioned grant for the purpose for which it is released.
- viii. The States Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
  - ix. The amount of Central Assistance approved will form a part of capacity building plan of the States under PMAY (Urban).
  - x. Where there is an element of cash transfer, the same may be made through PFMS/DBT mode as applicable.
- 3. The amount involved is debitable to the following Head of Account under Demand No. 56 of the Ministry of Housing and Urban Affairs for the year 2018-19 after duly re-appropriation from the respective Non-functional Head to the Functional Head for NE States:
