  - (iii) 2<sup>nd</sup> installment will be released on the basis of actual accepted geotagging points on Bhuwan portal for each project for which funds have been released. There are 5 stages available on Bhuwan portal for which beneficiaries can be geotagged including completion stage. Before release of 2<sup>nd</sup> installment the completion stage of all beneficiaries in a project must be done.
  - (iv) 2<sup>nd</sup> installment would be released to the State/UT as per actual and on receipt of Utilization Certificate along with undertaking/Certificate on Geo-Tagging Expenses (in prescribed format mentioned in Capacity Building Activities – Norms, fund Disbursal processes and Plan Templates).

- (vi)The amount of central assistance approved will form a part of capacity building plan of the States/UTs under PMAY (Urban) mission.
- (vii)Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individuals, the same may be made through PFMS/DBT mode, as applicable.
