Sub: Procurement of buses to be sanctioned under JnNURM during 2013-14 –
empanelment of consultants for preparation of DPRs for funding of buses for
urban transport under JnNURM.

Sir/Madam,

As you are aware the Union Finance Minister has announced the sanction of upto 10,000 buses during 2013-14 with special emphasis to Hill States. Ministry of Urban Development has already taken initiative for formal approval of Government of India before sanctioning these buses to the cities. This time Ministry is also proposing to sanction buses as well as ancillary infrastructure to all the cities/towns/urban agglomerations in India. Detailed information has been shared with all the States who were present during the consultation meeting held on 06.05.2013. The detailed guidelines for bus funding are under finalization and would be advised soon.

2. Since the programme is meant for sanction only in 2013-14 and the time left is short, Ministry of Urban Development is taking necessary action for empanelment of consultants to facilitate cities/towns in preparation of DPRs at the earliest. Meanwhile, a list of consultancy agencies, who had earlier provided their assistance in preparation of bus funding DPRs to Mission Cities under JnNURM, is as follows:-




