

**Sub: Release of Central Assistance under Pradhan Mantri Awas Yojana (PMAY) (Urban)-Housing for All Mission to State Government of Gujarat for the financial year 2018-19.**

Sir,

I am directed to convey the Sanction of the President of India to the release of **Rs. 1,01,75,65,000/- (Rupees One-Hundred-One Crore Seventy-Five Lakh and Sixty-Five Thousand only)** to the State Government of Gujarat as 1<sup>st</sup> instalment of central grant for Creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY)-Housing for All (Urban) Mission under allocation (Other than Scheduled Castes Component & Scheduled Tribe Component) for the FY 2018-19.

2. The statement showing details of the 10 AHP projects against which the above Grant is released towards 1<sup>st</sup> instalment of the Central Assistance is **annexed.**

3. Based on decision and recommendations of CSMC under Pradhan Mantri Awas Yojana (PMAY) (Urban) in its **32<sup>nd</sup> meeting held on 26.03.2018**, the amount of central grant is being released subject to the following conditions:

- i. Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- ii. The State Government and implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- iii. Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of Pradhan Mantri Awas Yojana (PMAY)-Housing for All (HFA) (Urban) Mission.
- iv. Furnish the Utilization certificates of the Grant released in the prescribed format as per GFR-2017 as provided in the scheme guidelines.
- v. The funds may be utilized for the purpose and within selected categorised beneficiary for which these are given. Otherwise these will have to be refunded along with interest as per provisions for GFR-2017.

- vi. State Should ensure that data entries in PMAY-MIS portal are completed at the earliest. 2<sup>nd</sup> instalment will be released based on valid beneficiaries entered in PMAY-MIS.
- vii. The agencies responsible for implementation of PMAY(U) should get themselves registered on PFMS portal.
- viii. The State Government should validate the demand assessment data and remove the ineligible beneficiaries in order to make the housing requirement realistic.
- ix. State to ensure that adequate infrastructure is ensured including individual water, sanitation and electric connection.
- x. State Government to ensure that there is no duplication/change in the identified beneficiaries.
- xi. Transfer of funds to different entries may be made through PFMS, as applicable, and where there is an element of cash transfers to individual beneficiaries, the same may be made through PFMS/DBT mode, as applicable.

4. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest, as applicable, for the period of default.

5. The payment is adjustable in the account of the Central Government in the books under the following Head of Account under Demand No. 56 of M/o. Housing and Urban Affairs for the year 2018-2019:

6. The amount will be credited to the State Government 's account in RBI as per procedure laid down by Ministry of Finance, Department of Expenditure in this regard.

7. This being the first installment of the central assistance under PMAY (U) for these approved projects, no UC is pending from the State Government.

9. This sanction has been registered at **Sl. No. 16** in the Sanction Register of HFA Mission Directorate (HFA-III Section) of the Ministry of HUA for the year 2018-19.
