Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of July, 2020.

I. Swachh Bharat Mission

- On Swachh Bharat Helpline (1969), for all issues related to Swachh Bharat,
 5.40 lakh calls have been answered with an average handling time of 1 minute
 28 seconds.
- ii. A total of 4,324 cities/ towns have been declared as ODF (Open Defecation Free), 1,319 cities have been certified as ODF+ and 489 cities have been certified as ODF++. An ODF++ city requires to achieve sanitation sustainability by addressing complete sanitation, including safe containment, processing and disposal of faecal sludge and septage.
- iii. 60,000 toilets across more than 2,900+ cities are live on Google Maps with the name of "SBM Toilet" covering 55% of urban population.
- iv. 502 cities have been registered on Swachh Nagar Mobile App so far. This app helps in effective waste management of a city like monitoring, collection of segregated waste, tracking the movement of waste vehicles etc.
- v. As on date 9,820 Garbage Vulnerable Points (GVP) have been mapped, out of which 1,250 are being monitored. 392 cities comprising of 2,363 active wards are using this module. The Swachh Survekshan 2020 has a dedicated indicator on monitoring and transformation of GVPs.
- vi. The number of cities with 5-Star Certification is 6, 3-Star Certification is 86 and 1-Star Certification is 65 under Star Rating Protocol for Garbage Free Cities.
- vii. Under Swachh Manch, 4,000 Urban Local Bodies (ULBs) are involved by posting of 1,52,690 events with more than 7.16 crore citizen's participation.
- viii. Shri Hardeep S. Puri, Minister of State (I/C), Ministry of Housing and Urban Affairs (MoHUA) launched the toolkit for sixth edition of the annual cleanliness survey of urban India 'Swachh Survekshan (SS) 2021' on July 03, 2020.
- ix. Ministry announced a new category of awards named 'Prerak Dauur Samman', in which the top 3 cities are being recognized in following 5 sub-categories: Divya (Platinum), Anupam (Gold), Ujjwal (Silver), Udit (Bronze), Aarohi (Aspiring) based on six select indicators:
 - Segregation of waste into Wet, Dry and Hazard categories
 - Processing capacity against wet waste generated
 - Processing and recycling of wet and dry waste
 - o Construction & Demolition (C&D) waste processing
 - Percentage of waste going to landfills
 - Sanitation status of cities
- x. An Integrated SBM-Urban MIS portal launched on 03.07.2020. The launch of the integrated MIS portal is an effort by the Ministry to bring the numerous digital initiatives on a single platform thus ensuring a unified and hassle-free experience for States and cities and leading the way towards the creation of not just a Swachh but a truly digital India. In order to make it easier for users to

use this portal effectively, series of webinars / training sessions were conducted for all States/ULBs. Total 16 trainings were conducted in two phases with phase-I focusing on updating city profiles and city facilities and phase II focusing on updating monthly service level progress during the period of 9 July to 30 July 2020 covering all states/UTs.

- xi. The Ministry launched two documents prepared by the Central Public Health and Environmental Engineering Organisation (CPHEEO) the 'Advisory on On-Site and Off-Site Sewage Management Practices' and the guidance book on 'Efficient Collection and Transportation of Municipal Solid Waste'.
- xii. Notable Information, Education and Communication (IEC) campaigns launched during the month of July:
 - · Main Bhi Swachhata Warrior' Campaign.
 - 'Jan Jan Ke Liye, Jan Janke Dwara' Campaign for World Population Day (11 July)
 - 'Paper Bag Sahi Hai' Campaign on World Paper Bag Day (12 July)

II. Smart Cities Mission (SCM)

- i. During the month work has been completed in 42 projects worth Rs. 405 crore. Work has been started for 105 projects worth Rs. 3,220 crore and tenders were issued for 90 projects worth Rs. 1,444 crore. Total of 4,810 projects worth Rs. 1,66,806 crore were tendered. Work orders have been issued for 3,945 projects worth Rs.1,27,440 crore, out of which 1,697 projects worth Rs. 27,249 crore have been completed.
- ii. Ministry of Housing and Urban Affairs launched the India Cycles 4 Change Challenge to support cities (5 lakh plus population/capital cities and Smart Cities) in implementing cycling-friendly projects, in response to COVID-19. The aim of the India Cycles4Change challenge is to create extensive cycling-networks through low-cost interventions like pop-up cycle lanes and traffic-calmed or non-motorized zones. Till now, 95 cities have registered under this challenge. The cycling intervention will be a pan-city initiative and not limited to the one area of the city only. The key outcome is to encourage cities to experiment cycling and build confidence for a city-level scale-up with the goal to learn, rather than plan to perfection. Smart City Mission with the assistance of the Institute for Transportation Development Policy(ITDP) India Programme and a panel of experts will review the submissions and shortlist the first set of cities which will move into second stage.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

 State Annual Action Plans (SAAPs) to the tune of Rs. 77,640 crore have been finalised for all the States. Detailed Project Reports (DPRs) have been approved for the projects costing Rs. 81,324 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount is such cases will be borne by the States/ULBs. Works have been completed for 2,830 projects worth Rs. 10,964 crore, contracts have been awarded for 2,695 projects worth Rs. 65,638 crore, 187 projects worth Rs. 3,522 crore are under tendering and DPRs worth Rs. 1,979 crore are under preparation.

ii. So far, Rs. 26,739.89 crore has been released to States/UTs towards project implementation including the eligible projects of erstwhile JnNURM, Administrative & Office Expenses (A&OE), Reform Incentive and for formulation of GIS based Master Plans & Local Area Plan (LAP) and Town Planning Schemes (TPS).

IV. Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

- i. 3,971 Self Help Groups (SHGs) have been formed, 1,885 SHGs were given Revolving Fund, 2,249 candidates were skill trained and certified, 462 trained candidates were given placement, 2,775 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 3,411 loans were given to SHGs under SHG-Bank linkage programme.
- ii. Under PM Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi), Loan disbursement commenced from 2ndJuly, 2020 through an online integrated IT platform PM SVANidhi Portal. Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) engage on 13th July, 2020 for administering the graded credit guarantee cover for PM SVANidhi. Mobile App for Lending Institutions launched on 17th July, 2020 and Common Service Centers (CSCs) integrated on 21st July, 2020 to facilitate beneficiaries across the country.

V. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. A total of Rs. 108.48 crore has been released during the month.
- ii. Since the inception of the Mission, it has achieved milestone of sanctioning more than 1.05 crore houses against the validated demand of 1.12 crore houses. 66.20 lakh houses have been grounded for construction of which 35.20 lakh houses have been completed/delivered.
- iii. The proposal to develop Affordable Rental Housing Complexes (ARHCs) for urban migrants/poor to provide ease of living as sub scheme under PMAY-U, has been approved by the Cabinet on 8th July, 2020.
- iv. Hon'ble Minister of State (Independent Charge), Housing and Urban Affairs released ARHC Knowledge Pack containing Operational Guidelines of ARHCs scheme, Model Request for Proposal (RFP), Expression of Interest (EoI) and Frequently Asked Questions (FAQs) and launched We-portals of CREDAI and NAREDCO on 31st July, 2020.
