



PENDING ISSUES



Demonstration Housing Project:

- The State Level Sanctioning and Monitoring Committee in its meeting held on 4.10.2018 decided to take up the Demonstration Housing Project to construct night shelter and a land has also been identified.
- Decision of the State Level Sanctioning and Monitoring Committee communicated to Ministry on 2.11.2018 with a request for in-principle approval of the Central Sanctioning and Monitoring Committee.

TPQMA:

- The State Level Sanctioning and Monitoring Committee had decided to appoint the Puducherry Engineering College as the TPQMA for the PMAY project on nomination basis.
- While seeking approval, the Hon'ble Lieutenant Governor has directed to obtain approval of the Ministry.
- A request has been submitted on 31.1.2019 seeking necessary approval / clearance of the Ministry to appoint the Puducherry Engineering College as TPQMA.

PENDING ISSUES



Relaxation for reconstruction of houses constructed under VAMBAY and IAY

- The Council of Ministers in its meeting held on 25.5.2018 (Resolution No. 2018/M.30/199) to seek relaxation from the Ministry of Housing and Urban Affairs for disbursement of financial assistance under the Pradhan Mantri Awas Yojana scheme for reconstruction of dilapidated houses of the beneficiaries who had earlier availed financial assistance under various State Housing schemes, Indira Awas Yojana and VAMBAY.
- The Hon'ble Minister for Housing, Government of Puducherry had already submitted a request to the Hon'ble Minister for Housing and Urban Affairs, Government of India in this regard seeking relaxation from the Ministry for reconstruction of houses constructed under IAY and VAMBAY schemes.
- A DPR was prepared by the Implementing Agencies to construct 158 houses which were in dilapidated condition in Yanam Planning Area. The State Level Sanctioning and Monitoring Committee has not recommended the proposal. However, it was decided to seek clarification as to whether the financial assistance would be possible for repair of house or for demolition of house, which has outlived its life, and construction of new house in its place.
