*** West Bengal has enacted its own Act namely 'West Bengal Housing Industry Regulation Act, 2017' however, state has been advised by MoHUA to notify the rules under Real Estate (Regulation & Development) Act, 2016.

Summary:

- **31** States/UTs have notified rules under RERA; 2 North Eastern States (*Nagaland and Sikkim*) are under process to notify the rules.
- **30** States/UTs have set up Real Estate Regulatory Authority (Regular - 24, Interim - 06)
- **24** States/UTs have set up Real Estate Appellate Tribunal (Regular -16, Interim – 08) (*Assam, Himachal Pradesh, Kerala, Mizoram and Lakshadweep are under process to establish*).
- Regulatory Authorities of **25** States/UTs have operationalised their websites under the provisions of RERA. (*Assam, Lakshadweep, Manipur & Puducherry are under process to operationalize*).
- **51,057** Real Estate Projects and **40,189** Real Estate Agents have registered under RERA across the country.
- **44,509** Complaints have been disposed-off by the Real Estate Regulatory Authorities across the country.
