Summary:

- **30** States/UTs have notified rules under RERA; 4 North Eastern States (*Arunachal Pradesh, Meghalaya, Nagaland and Sikkim*) are under process to notify the rules.
- **29** States/UTs have set up Real Estate Regulatory Authority (Regular 21, Interim 08) (*Lakshadweep is under process to establish*).
- **24** States/UTs have set up Real Estate Appellate Tribunal (Regular -14, Interim 10) (Assam, Goa, Himachal Pradesh, Kerala, Mizoram and Lakshadweep are under process to establish).
- Regulatory Authorities of **24** States/UTs have operationalised their websites under the provisions of RERA. (Assam, Kerala, Lakshadweep, Manipur, Puducherry & Tripura are under process to operationalize).
- **46,695** Real Estate Projects and **36,823** Real Estate Agents have registered under RERA across the country.
