## Present Status of Implementation of Real Estate (Regulation & Development) Act, 2016 (RERA):

- 28 States/UTs have notified rules under RERA except-
  - > Jammu & Kashmir (as RERA is not applicable there).
  - > 6 North Eastern States (Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland and Sikkim)
  - > West Bengal has enacted its own Act i.e. Housing & Industry Regulation Act (HIRA), however state has been advised by MoHUA to notify the rules under Real Estate (Regulation & Development) Act, 2016.
- 28 States/UTs have set up Real Estate Regulatory Authority (Regular 15, Interim 13).
- 21 States/UTs have set up Real Estate Appellate Tribunal (Regular -09, Interim 12).
- Regulatory Authorities of 23 States/UTs have operationalised their websites under the provisions of RERA.
- 34,674 Real Estate Projects and 26,882 Real Estate Agents have registered under RERA across the country.
