REVIEW MEETING ON CLSS UNDER PMAY (U) on 12th October, 2017

- A meeting was convened on 12th October, 2017 at 1500 hours by Joint Secretary and Mission Director (HFA), Ministry of Housing and Urban Affairs in his chamber at Nirman Bhawan, New Delhi to review the progress of CLSS component of PMAY (U) Mission. The list of participants is enclosed at *Annexure I*.
- The following items were discussed.
- 2.1 The following progress under CLSS (as on 11.10.2017) was informed by the Central Nodal Agencies:

2.2 NHB projected an additional requirement of Rs. 1,200 crore for meeting a cumulative target of 90,000 beneficiaries in the current FY.

(Action: HFA-4, Mission Directorate)

- 2.3 CNAs were advised to provide a schedule for the balance FY for Review and Appraisal Workshops with a focus on new initiatives undertaken, best practices, etc. CNAs were requested to target the following States/UTs:
- (i) HUDCO: North Eastern States, Uttar Pradesh, Madhya Pradesh, Bihar, Rajasthan
- (ii) NHB: Telangana, Andhra Pradesh, Tamil Nadu, Karnataka, Maharashtra, Gujarat (Action: NHB and HUDCO)
- 2.4 It was decided that the workshops being planned for CLSS should include a suitable section on the urban housing credit opportunity available under other verticals of PMAY(U) Mission as the SLNAs and PLIs are both present in the forum. This would enable awareness and involvement of State/UTs in facilitating PMAY(U) beneficiaries to avail this opportunity.

2.5 NHB was requested to provide inputs based on the decisions of the meeting with DFS on 20.09.2017 so that a follow up meeting with DFS could be convened.

2.6 NHB was requested to issue targets to HFCs under the CLSS for EWS/LIG/MIG for the current FY with a copy to MoHUA.

2.7 CNAs were requested to explore the feasibility of organising large scale events (eg. Bike rally, marathon, etc.) for mass awareness programmes in select States.
