

Increase in A&OE Grant :

Under A&OE head, presently a grant of **Rs. 90 Lakhs** per annum is sanctioned for state of Uttar Pradesh.

From April 2018 to December 2018 the expenditure under A&OE head was Rs. **326.32** Lakhs (details attached).

Due to large number of sanctioned houses in state and actual expenditure being so high, this grant needs to be increased to at least 3 times.

SLSMC has also recommended for the same.

PFMS Portal:

When payment is being made to the beneficiary for the second or third installment through PFMS portal, **no drop-down** or any tabular information is available as to how much payment has been made to that particular beneficiary and also there is **no option** of vertical selection either BLC N or BLC E in PFMS portal at the time of DBT.(<u>list of others issues attached</u>).

Currently 3 portal are working for execution of PMAY i.e. MIS, GIS and PFMS but there is no linkage between MIS and PFMS portal. State has raised this concern several times via email and letters but no solution being provided yet.(Letters <u>from PS</u> and <u>Director SUDA</u>).

In Uttar Pradesh, 100% DBT to beneficiary via PFMS portal.



2nd Instalment in AHP projects:

In AHP projects, 2nd instalment is being released as per the beneficiary attachment on MIS portal. As there is reservation in allotment of houses to the beneficiary, so achieving 100% allotment against sanction take lot of times.



Proposed DU Layout Plan & Room Sizes under BLC(N)








