Monthly Summary on the principal activities of Ministry of Housing and Urban Affairs for the month of June, 2019

I. Fourth Anniversary of Urban Missions

The completion of 4 years of Smart City Mission (SCM), Pradhan Mantri Awas Yojana (PMAY) and Atal Mission for Rejuvenation & Urban Transformation (AMRUT) was celebrated on 25 June 2019 and the key achievements and transformational change brought about these Missions were highlighted and the press was briefed.

II. Swachh Bharat Mission

- i. 1.50 crore citizens are registered on the Swachhata App, 1.77 crore complaints have been registered out of which 91 % complaints have been resolved by end of this month.
- ii. Rs. 65.19 crore has been released to the States during the month.
- iii. On Swachh Bharat Helpline (1969), for all issues related to Swachh Bharat, more than 4.85 Lakh calls have been answered with an average handling time of 1 minute 27 seconds.
- iv. 'Swachh Manch' is the citizen engagement platform where 1,08,654 events are posted, 1 crore people participated and 2,520 Urban Local Bodies (ULBs) are on board.
- v. 45,000 toilet blocks across 1,700 cities are live on Google Maps with the name of "SBM Toilet".
- vi. The Star Rating Protocol for Garbage Free Cities was launched by the Ministry in January 2018. Based on the feedback received from States and cities, the modified Protocol for Star Rating of Garbage Free Cities was issued on 28 June, 2019. The modified protocol is not only more objective in nature but will serve to strengthen the implementation of solid waste management rules at both city and ward level.
- vii. To maintain the momentum achieved by all Urban Local Bodies (ULBs) and to sustain the progress made, it was decided to assess all Urban Local Bodies (ULBs) on quarterly basis under 'Swachh Survekshan League-2020 (SSLeague-2020)'. The Swachh Survekshan League 2020 was launched on 06.06.2019 by Hon'ble Minister of State (I/C), Ministry of Housing & Urban Affairs for quarterly cleanliness assessment of cities and towns in India and will be integrated with Swachh Survekshan 2020.
- viii. A one-day National Workshop for Finalization of Draft Manual on Storm Water Drainage System, 2019 was organised with participation of 300 officials from the States and Urban Local Bodies (ULBs).

III. Smart Cities Mission

- i. Work had been completed in 45 projects worth Rs. 328 crore and work was started for 9 projects worth Rs. 2095 crore. With this, 913 projects worth Rs. 14,974 crore have been completed, 1,903 projects

worth Rs. 74,961 crore are currently under implementation and 802 projects worth Rs. 44,860 crore are under tendering.

ii. The Mission has seen a growth of over 240% in the last 5 quarters. Close to 60% of the total projects i.e. 3,600 projects worth Rs. 1,33,400 crore have been tendered of which 40% of the total projects i.e. around 2,800 projects worth about Rs. 89,000 crore have been grounded for implementation/ construction or are completed. The Mission has implemented numerous projects on ICCC, smart solutions and sustainable environment.

iii. The Smart Cities mission launched its 100 days programme 'One city One impact' wherein each of the 100 smart cities will submit a 100 day plan which will have an impact on following thematic areas: Inclusion, Environment, Cleanliness, Economy and Water. The 100 day plan will provide direct benefit to more than 2.5 Crore citizens across 100 smart cities in 100 days.

IV. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

i. State Annual Action Plans (SAAPs) to the tune of Rs. 77,640 crore have been finalized for all the States. Detailed project reports for projects costing Rs. 80,419 crore have been approved. 1,656 projects worth Rs. 4,198 crore have been completed, contracts have been awarded for 3,260 projects worth Rs. 61,072 crore and 335 projects worth Rs. 8,458 crore are under tendering and DPRs worth Rs. 8,195 crore are under preparation.

ii. So far, Rs.20,034.51 crore has been released to States/UTs towards project implementation, Administrative & Office Expenses, Reform Incentive and for formulation of GIS based Master Plans.

V. Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

i. 5,027 Self Help Groups (SHGs) were formed, 3,021 SHGs were given Revolving Fund, 5,074 candidates were skill trained and certified, 2,996 trained candidates were given placement, 2,437 beneficiaries were assisted with loans for setting up of individual and micro enterprises, and 2,237 loans were given to SHGs under SHG-Bank linkage programme.

ii. Rs. 164.27 crore was released during this month.

VI. Pradhan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)

i. A total of Rs. 648.54 crore has been released during the month.

ii. 81.03 lakh dwelling units in 17,113 projects with an investment of Rs. 4,95,838 crore involving Central assistance of Rs. 1,30,161 crore have

been approved under PMAY. So far, 48,31,580 houses have been grounded for construction, 26,07,913 houses have already been constructed and 23,96,783 houses have been occupied.

- iii. The release of grant was approved for the States of Assam, Bihar, Chhattisgarh, Jharkhand, Gujarat, Uttar Pradesh, Meghalaya, Nagaland, Tamilnadu and Maharashtra.

Housing

- i. 30 States/ UTs have notified rules under RERA; 4 North Eastern States namely Arunachal Pradesh, Meghalaya, Nagaland and Sikkim are under process to notify the rules under RERA.
- ii. 28 States/UTs have set up Real Estate Regulatory Authority (Regular - 20, Interim - 08).
- iii. 21 States/UTs have set up Real Estate Appellate Tribunal (Regular -13, Interim - 08).
- iv. Regulatory Authorities of 24 States/UTs have operationalised their websites under the provisions of RERA.
- v. 43,398 Real Estate Projects and 33,270 Real Estate Agents have registered under RERA across the country.

VII. Urban Transport

- i. Cabinet has approved the Surat Metro Rail Project for a total length of 40.35 km in two corridors namely corridor-1 (Sarhana to Dream City, 21.61 Km) and corridor-2 (Bhesan to Saroli, 18.74 km) at an estimated completion cost of Rs. 12,020.32 crore.

VIII. NBCC(India)

- i. NBCC signed a Memorandum of Understanding with Ministry of Housing & Urban Affairs which outlines the performance targets for the Company based on various financial and dynamic parameters.
