Sub: Return of dossiers of selected candidates of Steno Gr.C&D Exam, 2016.

The undersigned is directed to refer CPWD letter No.12/27/2015-EC-IV (SC) dated 03.08.2018 on the subject above. CPWD has stated that due to very late receiving of dossiers against the reported vacancy for Steno exam-2015 i.e. in 2017 from SSC, while reporting for Steno Exam 2016 some excess reporting was done. Later on (in 2017), when dossiers against the reported vacancy of 2015 were received, they are left with very limited vacancy (copy enclosed) and out of 67 dossiers sent to them for the year 2016, they are in a position to accommodate only 47 candidates. In view of that, they have returned the rest of the 20 dossiers as they are left with no vacancy at all.

2. Further, as may be aware, 2-UR candidates' dossiers have been withheld in this Ministry as, these have been received against the vacancy of 1-OH (CPWD) and 1-ExSM (TCPO) in this Ministry. After receiving clarification from SSC vide its letter no.26/5/2016/EDB (Part) dated 25.07.2018 that UR candidates may be appointed against the horizontal vacancy, this Ministry may be in a position to accommodate only one UR candidate with highest rank i.e. Sh. Govind Singh (Roll No.2201041452, Rank SL/362) in its TCPO office. **Accordingly, rest 21 (twenty one dossiers) as per list attached are being sent to as there is no vacancy in this Ministry to accommodate these candidates. May kindly acknowledge the receipt through return mail.**
