It diversified in other areas like Power Plants, Mining Projects, Irrigation Projects including Dams and barrages, Oil Refineries, Railways, Airport, Building and Commercial Complexes, Rural Roads, Highways etc. HSCL is Schedule 'B' CPSE in Contract & construction and tech. Consultancy services with the administrative jurisdiction of Ministry of Housing and Urban Affairs. The company employed 25 regular employees (Executives 21 & Non-Executives 04) as on 31.3.2018. The Registered Office of the company is located at Kolkata, West Bengal and Corporate Office is at New Delhi. The authorized and paid up share capital of the Company was Rs. 1619.30 crore and Rs. 70.00 crore respectively as on 31.03.2018.

#### 2. EMPLOYMENT STATUS:

(ii) Officers of Organized Group 'A' Accounts Services [i.e. Indian Audit and Accounts Service, Indian Defence Accounts Service, Indian Railway Accounts Service, Indian Civil Accounts Service, Indian P&T Accounts & Finance Service and Indian Cost Accounts Service] working in the appropriate level are exempted from these educational qualifications.
