

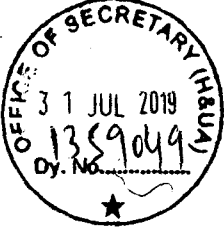



### I. COMPANY PROFILE

HSCC (India) Limited earlier known as Hospital Services Consultancy Corporation Limited is a Schedule 'C' Mini Ratna CPSE, and 100% subsidiary under NBCC (India) Limited., which is the holding Company under the Ministry of Housing & Urban Affairs, Government of India.

On 06th of November 2018, NBCC signed share purchase agreement with MoHFW for 100% shares of HSCC (I) Ltd as subsidiary of NBCC (I) Ltd.,

HSCC India Limited was incorporated under the Indian Companies Act, 1956 with the objective to be a market leader in providing innovative, high quality knowledge based services in the health and social sectors by seeking opportunities in special market niches and to develop as a consultancy organisation with contemporary professional standard in the field of healthcare.

Its Registered office is at Delhi.

The authorised and paid up share capital of the Company is Rs. 5 crores and Rs. 1.8 crores respectively as on 31.03.2019.

The company employed 124 regular employees (Executive 97, Non-executives 27) as on 31.03.2019.

### II. JOB DESCRIPTION AND RESPONSIBILITIES

The Director (Engineering) is a member of Board of Directors and reports to Chief Executive of the Company. The Director (Engineering) is responsible for planning, monitoring, execution and implementation of various projects.

- Central Government including the Armed Forces of the Union and All India Services;
- State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 500 crore or more**;
- Private Sector in company where the annual turnover is **\*Rs 500 crore or more**.

(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

**3. QUALIFICATION:**

The applicant should be a Civil Engineering Graduate with good academic record from a recognized university/Institute.

MBA/ Post Graduate Diploma in management is desirable.

**4. EXPERIENCE:**

The applicant should possess adequate managerial experience at a senior level in an organisation of repute in Project Planning, Execution, Monitoring and Implementation of large value PMC/EPC Projects in building construction sector.

Experience in consultancy/ technology/ projects in areas like health care infrastructure, construction of large Hospitals and Medical Colleges is desirable.

#### **6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

#### **IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

(b) Whether the company is listed or not; if yes, the documentary proof (please provide URL or attach/enclose copies);

(d) Self-attested copies of documents in support of age and qualifications;

- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
