#### I.COMPANY PROFILE

Housing & Urban Development Corporation Ltd. (HUDCO) was set up with the objective to meet the financial needs of the institutions in housing and urban sector such as housing boards, development authorities, municipalities, cooperatives etc. in the country through a system of project financing. HUDCO is a national level techno financial organisation in the field of housing and urban development. It is a Schedule 'A', Mini-Ratna CPSE with the administrative jurisdiction of Ministry of Housing and Urban Affairs. The company employed 753 regular employees as on 31.3.2021.

Its Registered and Corporate offices are at New Delhi.

The authorised and paid up capital of the Company was Rs. 2500 crore and Rs. 2001.90 crore respectively as on March 31, 2020.

The shareholding of the Government of India in the Company is 81.81%.

#### II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Corporation and is accountable to its Board of Directors and Government. He/She is responsible for all the activities of the corporation including personnel, financial and commercial management, corporate planning and project implementation. He/She is responsible for the efficient functioning of the Corporation and for achieving its corporate objectives and performance para-meters.
