In this regard, each Department/Division/Section under Ministry of H&UA is requested to nominate an officer who shall function as the Sub-Nodal Officer for their respective unit and shall be responsible for submission of requisite information as per **Annexure-C**. Further, a Link Officer may also be nominated to discharge these responsibilities in the absence of the Sub-Nodal Officer.

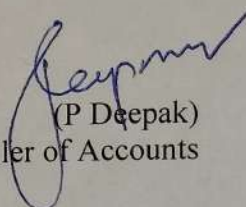
