Sub: Release of 2nd Installment of Grants-in-aid to the State Government of Kerala for Slum Free City Plan Scheme (SFCEP) under Rajiv Awas Yojana during 2012-13.

Sir,

The undersigned is directed to convey the sanction of the President of India to the payment of Rs. 331.00 lakhs (Rupees three hundred thirty one lacs only) as 2<sup>nd</sup> instalment to the State Government of Kerala for preparatory activities under RAY.

2. The above grant is subject to the following conditions:
- The above amount of 2<sup>nd</sup> instalment has been sanctioned based on the demand (50% of the amount demanded) submitted by the State Government. The final settlements of grants will be as per the approved financial norms of each component of preparatory and other activities of RAY as decided by the Central Sanctioning & Monitoring Committee (CSMC) under RAY held on 19<sup>th</sup> January 2012. The State will comply with the terms and conditions stipulated in the minutes of the said CSMC meeting and RAY guidelines. In cases where expenditure incurred on any component is above the approved ceiling, the excess amount to be borne by the State Government.
  - The grant sanctioned will be utilized for the purpose for which they are sanctioned for, otherwise they will have to be refunded along with interest as per the provisions of GFR's.
  - The State Government/Nodal Agency shall furnish physical and financial progress reports (*every quarter*) regarding implementation of project undertaken.
  - State Government of Kerala is required to furnish Utilization Certificate in the prescribed form and Statement of Expenditure to the Government of India as soon as the fund utilisation exceeds 70% of the amount released.
  - The State Government/Nodal Agency shall strictly monitor the progress of the project as per the Guidelines of the Scheme so that there is no need to seek relaxation for submission of Utilization Certificate along with physical and financial progress report.
