OFFICE MEMORANDUM

Subject: Extension of time by two years upto 2013-14 for completion of projects sanctioned till March 2012 and extension of period of implementation of reforms, etc. under the Sub-Mission on Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) under Jawaharlal Nehru National Urban Renewal Mission (JNNURM).

The undersigned is directed to say that the Jawaharlal Nehru National Urban Renewal Mission (JNNURM) was launched by the Government of India on 3rd December, 2005 to implement reform-driven, planned development of cities in a Mission mode with focus on upgradation of urban infrastructure and provision of basic services to the urban poor, community participation and accountability of Urban Local Bodies (ULBs). Duration of the Mission was seven years beginning from 2005-06 till 2011-12.

2. It has come to the notice of this Ministry that most of the projects sanctioned under the Sub-Mission on Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) of Jawaharlal Nehru National Urban Renewal Mission (JNNURM) are at various stages of implementation and completion of sanctioned projects and implementation of 3 pro-poor reforms will go beyond 31.3.2012.

3. In view of this, with the approval of the competent authority, it has been decided to extend the Mission period by 2 years upto the end of Financial Year 2013-14 for completion of projects sanctioned upto March 2012 and implementation of 3 pro-poor reforms under BSUP and IHSDP components of JNNURM. However, it is clarified that sanctioning of new projects under BSUP and IHSDP has not been envisaged during this extended period.

4. It has further been decided to extend for the same period, the structures and support for Mission as approved from time to time and utilization of funds for the purposes such as Administrative and Other Expenses (A&OE), Programme Monitoring Units/Project Implementation Units (PMU/PIU), Detailed Project Report (DPR) Preparation Charges, Third Party Inspection and Monitoring Agency (TPIMA) Expenditure, funding for various activities related to "Project Implementation & Quality Assurance" and "Community Mobilization", etc.

5. The release of ACA will be governed as per the existing guidelines of BSUP/IHSDP and the relevant Toolkits for structures and support of the Mission.

6. All State/UT Governments are requested to expedite the implementation of the sanctioned projects and implementation of 3 pro-poor reforms. It is also requested to submit an action/implementation plan for completion of the incomplete projects and reforms and for funds utilization etc. to this Ministry expeditiously, **before 31st May, 2012**. While submitting the proposals for release of ACA the State/SLNA shall send the current status and implementation of 3 pro-poor reforms as per Worksheet-3 in respect of the ULBs for which ACA is claimed so as to avoid delay in release of ACA as per the guidelines of BSUP/IHSDP.
