The reimbursement is in accordance with the approved rates and out of HFA funds under the Ministry of Housing & Urban Poverty Alleviation.



6. This sanction has been registered at Sl. No 41 in the Sanction Register of HFA of Ministry of HUPA for the year 2015-16.


