

**MINUTES OF THE 15<sup>th</sup> MEETING OF THE CENTRAL SANCTIONING AND  
MONITORING COMMITTEE (CSMC) UNDER RAJIV AWAS YOJANA (RAY)  
IMPLEMENTATION PHASE**

Nirman Bhawan, New Delhi, 13<sup>th</sup> March, 2015

1. The 15<sup>th</sup> Meeting of the Central Sanctioning and Monitoring Committee (CSMC) of Rajiv Awas Yojana (RAY) Implementation phase was held under the Chairpersonship of the Secretary, Ministry of Housing and Urban Poverty Alleviation on 13<sup>th</sup> March, 2015 at 3:30 PM in Room No: 123, C-wing, Nirman Bhawan, New Delhi. The list of participants is at **Annexure - I**.
2. CSMC considered the proposal as per Agenda circulated and presentation made by State representative. Agenda Note circulated for the meeting is also part of these minutes.
3. CSMC confirmed the minutes of 14<sup>th</sup> meeting held on 27<sup>th</sup> February, 2015.

**RELEASE OF 2<sup>nd</sup> INSTALLMENT**

**MADHYA PRADESH**

4. **Proposal for sanction of 2<sup>nd</sup> Instalment of ACA for the pilot DPR of identified 5 slums as per Slum Free City Plan of Gwalior Municipal Area (934 DUs) under RAY.**
  - 4.1. The State representative apprised the CSMC that the project was approved in the 2<sup>nd</sup> CSMC meeting (preparatory phase) held on 19.01.2012 with a total project cost of Rs 5715.52 Lakh and Central share of Rs 2526.36 Lakh. State representative informed that work of 630 DUs has been started out of 934 sanctioned DUs and Rs 1256.21 Lakh (i.e. 72% of released amount of Rs 1743.78 Lakh including Central, State and Beneficiary share) have been utilized. The State representative also informed that all the beneficiaries have been identified and are being linked with their Aadhar number. It was also informed that in the absence of TPIMA, the SLNA is supervising the project for structural and quality control. The state representative requested for release of 2<sup>nd</sup> installment of Central share i.e. **Rs 1010.54 Lakh.**
  - 4.2. The committee directed the State representative to submit the Certificate of SLNA with regard to supervision of the work being executed under the project. The State Representative assured the committee for the submission of the same. The committee after deliberations, approved release of 2<sup>nd</sup> installment of ACA i.e. **Rs. 1010.54 Lakh** for the above project as per details at **Annexure II** and subject to the certification of SLNA.
5. The meeting ended with vote of thanks to the Chair
