Sir.

The undersigned is directed to convey the Sanction of the President of India to the payment of Rs. 4,32,00,000/- (Rupees Four Crore Thirty Two Lakhs only) to the UT Government of Puducherry as central assistance for Creation of Capital Assets under Pradhan Mantri Awas Yojana (Urban) under Plan allocation for the FY 2016-2017.

- 2. A statement showing details of the projects against which the above assistance towards 1<sup>st</sup> instalment of the Central Assistance stand sanctioned to UT Government of Puducherry is annexed.
- 3. The sanction is based on the approval and recommendation of CSMC of MoHUPA under Pradhan Mantri Awas Yojana (Urban) in its 17<sup>th</sup> meeting held on 20.12.2016. The amount of central assistance is being released subject to the following conditions:
- (i) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (ii) The Government of Puducherry and implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iii) The UT Govt./implementing agencies shall utilize the assistance in accordance with the approved guidelines for the implementation of the Scheme of PMAY(U).
- (iv) The UT Govt./ULB shall provide funds as per approvals in the projects.
- (v) The UT Government shall furnish Utilization certificates of the Grant released in the prescribed format (form 19-A) as per GFR 2005 and as provided in the scheme guidelines.
- (vi) The funds shall be utilized for the purpose for which these are sanctioned; otherwise these will have to be refunded along with interest as per provisions for GFR-2005.
- (vii) Transfers of funds to different entities and individual beneficiaries shall be made through PFMS/DBT, as applicable.
- 4. The sanctioned fund may be released to the UT Government immediately. The fund may thereafter be released to the implementing agencies by the UT Government without any delay failing which the amounts would be recovered from the UT Government with interest for the period of default.
