Subject : Setting up of Mission Directorate of Sub-Mission on 'Basic Services to the Urban Poor' & assignment of responsibilities for successful implementation of Jawaharlal Nehru Urban Renewal Mission (JNNURM).

In order to ensure successful implementation of Sub-Mission on Basic Services to the Urban Poor (BSUP) under Jawaharlal Nehru National Urban Renewal Mission, it is hereby ordered as under:-

2. A Mission Directorate comprising the following officials is set up with immediate effect:-

3. Mission Director for the Sub-Mission on Basic Services to the Urban Poor (BSUP) will be designated as Joint Secretary (BSUP). Till such time JS (BSUP) is in place, JS(HEPA) will look after the work relating to the Mission Director.

4. Mission Directorate will process proposals/DPRs received from Mission Cities, obtain sanction of competent authorities, ensure that Ministry of Urban Development has approved the CDP formulated by the cities, and MOA has been signed by Ministry of Urban Development, and release funds to State level Nodal Agencies after completion of formalities.

5. JS(BSUP) as Mission Director for Sub-Mission on BSUP will be responsible for the following:

- i. Appraisal of DPRs (prepared by empanelled agencies/consultants) by technical wings of the Government like HUDCO, Yashada, AILSG, CPHEEO, NIUA and TCPO.
- ii. Convening meetings of Central Sanctioning & Monitoring Committee and assisting the Committee in sanction of projects.
- iii. Sanction and release of funds to concerned State Level Nodal Agencies.
- iv. Providing technical assistance/guidance to concerned States and ULBs for preparation of DPRs.

6. Director (UPA), Director (NBO) and DS (NSDP) shall be the Coordinators for Sub-Mission on BSUP in respect of the States allocated to them in addition to their own duties. For the purpose of Mission, Director (NBO) is designated as OSD in the Mission. The Co-ordinators will closely associate themselves with the States and cities and help them in operationalisation of various components of the Sub-Mission. 7. The Coordinators will be responsible for the following in respect of the States/Cities allocated to them:-

- i. To remain in overall charge of States and Cities allocated for successful implementation of Sub-Mission on BSUP.
- ii. To guide the State Governments and cities in preparation of DPRs in accordance with provisions contained in guidelines of the Sub-Mission.
- iii. To have DPRs appraised by the empanelled agencies/technical wings of the Ministry and take expeditious step for sanction and release of funds to implementing agencies.
- iv. To undertake periodical visits to the States/Cities under their charge to have first hand knowledge of what is obtaining on ground and interact with the senior officials of the State Governments and ULBs for resolution of problems/difficulties faced by them.
- v. To monitor progress of implementation of projects sanctioned under JNNURM.
- vi. To closely monitor implementation of reform, in consultation with Ministry of Urban Development, timeliness/milestones envisaged in MoA for implementation of mandatory as well as optional reforms envisaged under the Sub-Mission.
- vii. To provide handholding support to the State Governments, State Level Nodal Agencies and ULBs in order to ensure implementation of reforms (where these reforms concern Ministry of UEPA) training and capacity building of agencies/organizations responsible for implementation of projects/reforms.
- viii. To assist State Level Nodal Agencies in eliciting project proposals, release of funds to ULBs, recovery and management of revolving fund, and monitoring of physical and financial progress of sanctioned projects.
- ix. To apprise Central Sanctioning and Monitoring Committee and National Steering Group of progress achieved, difficulties, if any, by way of submission of periodical reports through the Mission Directorate.

As you already know, the Hon'ble Prime Minister has launched a Mission named Jawaharlal Nehru National Urban Renewal Mission on 3rd December, 2005. The Mission comprises two Sub-Missions – one for Basic Services to the Urban Poor (BSUP) and the other for Urban Infrastructure & Governance. These Sub-Missions are for select 63 cities. For other cities/towns two schemes, namely, Integrated Housing & Slum Development (IHSDP) and Urban Infrastructure Development for Small and Medium Towns have also been launched on 3.12.2005. Ministry of Urban Employment & Poverty Alleviation is the nodal Ministry for BSUP and IHSDP.

2. As could be seen from the attached Guidelines on BSUP, a City Development Plan is required before the city can access Mission funds. The State Governments and the Urban Local Bodies (ULBs)/Parastatals are required to execute a Memorandum of Agreement (MoA) with Government of India indicating their commitment to implement the identified reforms. Signing of this tripartite MoA is a necessary condition to access Central assistance.

3. The cities are also required to prepare Detailed Project Reports for undertaking projects under identified areas. Appraisal of such DPRs is vital in the sanctioning of projects. It has, therefore, been decided that services of HUDCO, YASHADA, AILSG, CPHEEO, TCPO, NIUA and BMTPC would be engaged for appraisal of DPRs submitted under the Sub-Mission on BSUP. A copy of this Ministry's Office Order No.46020/81 /2005-Coord dated 10th January, 2006 is enclosed for your ready reference.



