- (iv) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of RAY and Pradhan Mantri Awas Yojana (PMAY) (Urban) Mission as well.
- (v) Furnish the Utilization certificates of the Grant released in the prescribed format as per GFR 2005 as provided in the scheme guidelines.
- (vi) Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.
- (vii) State Government should ensure that matching ULB share is released before the 3rd instalment of Central Share is claimed.
- 4. The State Government should pass on the central fund along with their matching share to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
