Subject: **Release of 2nd Installment of Rs. 730.81 lakhs as Central Assistance for RAY project (Kumarghat) subsumed in Pradhan Mantri Awas Yojana-(Urban) Mission for the financial year 2016-17- reg.**

Sir,

The undersigned is directed to convey the Sanction of the President of India to the release of 2^{ns} installment of **Rs. 7,30,81,000/- (Rupees Seven Crore Thirty Lakh and Eightyone Thousand Only)** to the State Government of **Tripura** being ACA (Grant) for Capital Creation under RAY project subsumed in **PMAY(U)** under Plan allocation for the FY **2016-17** for construction of 507 new DUs and upgradation of 111 Nos. DUs in Kumarghat Town of Tripura under RAY project.

2. The statement showing details of the projects against which the above amounts stand sanctioned to state is **Annexure enclosed.**

3. Based on decision of **CSMC** in its **23rd meetings held on 20th September, 2016** and on the recommendations made by MoHUPA, the amount of ACA is being released subject to the following conditions:

- (i) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s)
- (ii) The States Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve its scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iii) These project (s) shall be completed within the period of **PMAY-(U)** (RAY liabilities) for implementation of projects.
- (iv) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme.
- (v) Provide the State Share in the sharing pattern between the Central Government and the State Government, .as per RAY Scheme.
- (vi) Furnish the Utilization certificates of the Grant released for the RAY in the prescribed format as per GFR-2005.
- (vii) The funds may be utilized for the purpose for which they are given. Otherwise they will have to be refunded along with interest as per provisions for GFR-2005.
- (viii) Transfer of funds to different entities/individuals shall be made through PFMS/DBT mode, as applicable.

4. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.

5. The payment are adjustable from the account of the Central Government in the books under the following Head of Account under Demand No. **50 (Plan)** of M/o Housing and Urban Poverty Alleviation for the year **2016-17**:


