Minutes of the 6th CSSC Meeting

6th meeting of Central Sanctioning & Steering Committee (CSSC) was held at 16:15 hours on 1st March 2024, in Conference Room No. 123-C, Nirman Bhawan, New Delhi under the Chairmanship of Secretary (Ministry of Housing & Urban Affairs) to consider the proposals received from the States/Cities under PM-eBus Sewa Scheme. - 2. Director (UT) welcomed all the Members of the CSSC and made a brief presentation on the proposal of cities as recommended by Project Monitoring and Evaluation Committee (PMEC) in its meeting held on 1st March, 2024. (Minutes of the meeting of PMECs enclosed Annexure 'II').
- 3. **Proposal for deployment of eBuses**: The proposals of 16 cities for 1172 buses were discussed and the committee sanctioned the buses (as per the details given below) subject to submission of necessary documents as per the scheme guidelines.

Remarks: -

- (a) For Jaipur, it was decided to check the feasibility of 9m and 7m buses instead of all 12m buses.
- For Durg-Bhillai Nagar, Bilaspur & Korba cities of Chhattisgarh State, proposals are shortly expected. Since the upcoming tender is due, and if the demand from these cities is received, they may be considered for demand aggregation along with the approved demand of Raipur city for upcoming tender, however the tender shall be awarded only after the approval of the proposal by CSSC.
- 4. **Behind-the-meter power infrastructure proposals**: The proposals of 7 depots from 5 cities of 3 States (Maharashtra, Odisha, and Punjab) for Behind-The-Meter (BTM) power infrastructure proposals were presented. Based on the deliberations held during the meeting, the Committee sanctioned the proposals of 5 depots of 4 cities as per the details given below.

For remaining proposals, observation of the committee is as follows:

- For Vasai Virar, the combined estimated cost for BTM infrastructure of both the depots seems to be on higher side and thus needs to be reviewed.
- 5. **Civil infrastructure of Bus depot**: The proposals of 7 cities from Maharashtra for Depot civil infrastructure were presented before the committee. Based on the deliberations during the meeting, the Committee sanctioned the proposals of 7 cities as per the details given below.
