The undersigned is directed to convey the Sanction of the President of India to the payment as part of 3<sup>rd</sup> & final installment amounting to Rs. 88,93,000/- (Rupees Eighty Eight Lakh Ninety Three Thousand only) to the State Government of Gujarat being Central Assistance (Grant) for Creation of capital assets for the 2 RAY projects subsumed in PMAY- Housing for All (Urban) mission for State's Annual Plan 2017-2018.

2. The statement showing details of the projects against which the above amount stand sanctioned to State Govt. is as under:-



\* The Ministry of Finance has revised funding pattern from 75:25 to 60:40 for the projects having population less than 5 lakhs under RAY. For the project in cities having population more than 5 lakh, the funding pattern has been kept the same i.e. 50:50. In the instant case, both the projects are in cities having population more than 5 lakh, hence no change in funding pattern.

3. Based on decision of CSMC in its 22<sup>nd</sup> meeting held on 27.05.2016 and on the recommendations made by MoHUPA, the amount of central assistance is being released subject to adhering to the following conditions:

- (i) These project shall be completed as per the commitment.
- (ii) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (iii) The State Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve its scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iv) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme. Otherwise it will have to be refunded along with interest as per provisions for GFR-2017.
- (v) The fund may be utilized for the purpose for which they are given. Otherwise they will have to be refunded along with interest as per provisions of GFR-2017.
- (vi) Furnish the Utilization certificates of the Grant released for the PMAY-HFA (Urban) in the prescribed format as per GFR – 2017.
- (vii) The State should prepare and submit a video documentary on the success story of the beneficiaries benefited in the project.
- (viii) Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.

4. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.

5. The payment are adjustable in the account of the Central Government in the books under the following Head of Account under Demand No. 56 of M/o. Housing and Urban Poverty Alleviation for the year 2017-18:
