**Subject: Extension of time by two years upto 31.03.2017 for completion of projects sanctioned till March 2012 under the Sub-Mission on Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) components of Jawaharlal Nehru National Urban Renewal Mission (JNNURM).**


The undersigned is directed to refer to this Ministry's OM No.N-11027/3/2012-BSUP/IHSDP/JNNURM/FTS-5089 dated 18<sup>th</sup> September, 2013 conveying therewith the decision of the competent authority for extension in duration upto 31.03.2015 for completion of the projects sanctioned till 31.3.2012 under the Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) - components of Jawaharlal Nehru National Urban Renewal Mission (JNNURM). A copy of referred OM is enclosed for ready reference .

2. Subsequently, the position has been reviewed in the Ministry and it has been noticed that some of the projects sanctioned under the Sub-Mission on Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) of Jawaharlal Nehru National Urban Renewal Mission (JNNURM) are still at various stages of completion. The State Governments have also been requesting for extension of time to complete ongoing projects.

3. With the approval of the competent authority, it has, therefore, been decided to further extend the Mission period for BSUP and IHSDP components of JNNURM by two years beyond 31<sup>st</sup> March 2015, i.e. upto 31.03.2017 for completion of the projects sanctioned upto March 2012. It is reiterated that no new projects under BSUP and IHSDP will be sanctioned during this extended period.

4. Release Mechanism and conditions thereof for the Central funds in case of BSUP projects will be as stipulated in the cited OM dated 18<sup>th</sup> September, 2013.



**OFFICE MEMORANDUM**

Subject: Extension of time period by one year upto 2014-15 for completion of projects sanctioned till March 2012 and implementation of reforms under the Sub-Mission on Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) – components of Jawaharlal Nehru National Urban Renewal Mission (JNNURM).

The undersigned is directed to refer to this Ministry's OM No.N-11027/3/2012-BSUP/IHSDP/JNNURM dated 24<sup>th</sup> April, 2012 conveying therewith the decision of the competent authority for extension in duration by two years (i.e. upto 2013-14) for completion of the projects sanctioned till 31.3.2012 under the Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) - components of Jawaharlal Nehru National Urban Renewal Mission (JNNURM) and implementation of 3 pro-poor reforms.

2. A number of projects sanctioned under the Sub-Mission on Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP) of Jawaharlal Nehru National Urban Renewal Mission (JNNURM) are still at various stages of completion. The State Governments have also been requesting for extension of time by one more year in order to complete ongoing projects.

3. With the approval of the competent authority it has, therefore, been decided to further extend the Mission period for BSUP and IHSDP components of JNNURM by one year upto the end of Financial Year 2014-15 i.e. till 31<sup>st</sup> March 2015 for completion of the projects sanctioned upto March 2012 under BSUP and IHSDP components of JNNURM. However, it is clarified that no new projects under BSUP and IHSDP will be sanctioned during this extended period.

4(a). It has further been decided that henceforth release of central funds in case of BSUP projects under JNNURM will be made in 3 installments instead of 4. Accordingly, now the release mechanism under BSUP will be as under:

Types of cases	Position as per existing mechanism under BSUP	Proposed mechanism for release of Central funds
Case I	Where no releases of Central fund have been made so far.	Release will be made in three installments of 40%, 40% & 20% each.
Case-II	Where 1 <sup>st</sup> installment of 25% Central fund has already been released.	Remaining funds will be released in two installments of 55% & 20%.
Case-III	Where 50%, i.e. 2 installments of 25% each of Central fund, have already been released.	Remaining 50% will be released in last installment.
Case-IV	Where 75%, i.e. 3 installments of 25% each of Central fund have been released.	Remaining 25% will be released in last installment.

4(b). There will be no changes in the release mechanism under IHSDP component of JNNURM.

All subsequent releases will be made on receipt of 70% Utilization Certificate of earlier Central release.

5. The Programme Monitoring Units/Project Implementation Units (PMU/PIU) sanctioned under JNNURM component of MoHUPA will be merged with the proposed State Level Technical Cell (SLTC) proposed to be set up under RAY, for which separate guidelines are being issued. Hence no funds will be sanctioned for existing PMU/PIU established under JNNURM component of MoHUPA.

6. Non-starter projects under BSUP & IHSDP Components of JNNURM that could not be started as yet are required to be submitted for cancellation by CSMC/CSC, as the case may be, latest by 31<sup>st</sup> October, 2013 positively. However, the States / UTs will have the option to propose them afresh under RAY as per RAY Guidelines.

7. All State/UT Governments are, therefore, requested to expedite the completion of the on-going projects and implementation of 3 pro-poor reforms by March, 2015 as no funds will be released beyond that date. It is also requested to submit an action/implementation plan for completion of the incomplete projects, reforms, for funds utilization and details of projects proposed for cancellation to this Ministry expeditiously, before 31<sup>st</sup> October, 2013. While submitting the proposals for release of ACA the State/SLNA shall send the current status and implementation of 3 pro-poor reforms as per Worksheet-3 in respect of the ULBs for which ACA is claimed so as to avoid delay in release of ACA as per the revised mechanism.
