



Sir,

I am directed to convey the Sanction of the President of India to release an amount of **Rs. 49,55,057/- (Rupees Forty-Nine Lakh Fifty-Five Thousand and Fifty-Seven only)** to the State Government of **Rajasthan** being ACA (Grant) for Capital Creation under RAY project subsumed in PMAY-HFA (U) Mission for State's Annual Plan 2017-18 (**Scheduled Tribe Component**).

* The ACA released now is balance of 2nd installment after amended Central Share, vide letter No. 16/12/US(IFD)/2014 dated 23rd November, 2015, now so as to keep it as 80% (ACA is released in 40:40:20 ratio) of Central Share.

3. Based on decision of CSMC (RAY) in its 24th meeting held on 21st December, 2016 and on the recommendations made by MoHUA, the release of ACA is subject to the following conditions:

- (i) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (ii) The State Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iii) This project shall be completed within the period of Housing for All Mission for implementation of project.
- (iv) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of RAY and Pradhan Mantri Awas Yojana (PMAY) - Housing for All (HFA) (Urban) Mission as well.
- (v) Furnish the Utilization certificates of the Grant released in the prescribed format as per GFR – 2017 as provided in the scheme guidelines.
- (vi) The funds may be utilized for the purpose for which these are given. Otherwise these will have to be refunded along with interest as per provisions for GFR-2017.

- (vii) Interest on unutilized ACA shall be charged from the date of release of the ACA till date of its final adjustment / recovery, from the State concerned.
- (viii) Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individual beneficiaries, the same may be made through PFMS/DBT mode, as applicable.

4. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.

5. The amount is debitible from the account of the Central Government in the books under the following Head of Account under Demand No. 56 M/o Housing and Urban Poverty Alleviation for the year 2017-18:
