2. The above grant is subject to the following conditions:

- The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- The State will utilize the sanctioned grant for the purpose for which it is released.
- 2nd installment will be released on the basis of actual accepted geotagging points on Bhuvan portal for each project for which funds have been released. There are 5 stages available on Bhuvan portal for which beneficiaries can be geotagged including completion stage. Before release of 2nd installment the completion stage of all beneficiaries in a project must be done.
- The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- The amount of central assistance approved will form a part of capacity building plan of the State under PMAY (Urban) mission.

(vi) Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individual beneficiaries, the same may be made through PFMS/DBT mode, as applicable.




