Sir,

I am directed to convey the sanction of the Competent Authority to the release of **Rs. 18,90,000/- (Rupees Eighteen Lakh and Ninety Thousand only)** as 1<sup>st</sup> instalment of Central Assistance to State Govt. of Arunachal Pradesh for preparation of Housing for All Plan of Action (HFAPoA) for 4 towns under Pradhan MantriAwasYojana (Urban) {PMAY(U)} Mission for FY 2019-20. Details of funds being released are at Annexure.

- 2. The above grant is subject to the following conditions:
  - i. The above amount is first instalment of grants approved as per the Capacity Building guidelines under PMAY(U).
  - The above release is only for those cities which are approved by this Ministry under HFA mission.
  - iii. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
  - iv. State/cities to which assistance under RAY for preparation of SFCPoA have been given, should fully utilize that amount for preparation of HFAPoA, if the same City has been included under HFA.
  - v. As per minutes of 1<sup>st</sup> CSMC meeting held on 17.09.2015, rates mentioned in Capacity Building guidelines will serve as a ceiling for limits of Central Assistance and State/ULBs will have to adopt an open and transparent bidding procedure for procurement of these service. The applicable Central Assistance would be on tendered rates approved or applicable ceiling for Central Assistance, whichever is lower.
  - vi. The State Govt. is required to furnish Utilisation Certificate as per GFR-2017 and Statement of Expenditure to the Govt. of India before claiming next installment on utilisation of 70% of the amount released earlier for the preparation of SFCPoA and the instant release of preparation of HFAPoA.
  - vii. The amount Central Assistance approved will form a part of capacity building plan of the state under PMAY(U) Mission.

- viii. The grant sectioned will be utilized for the purpose for which it is released. The State Government/Nodal Agency shall strictly monitor the progress of the property work and finish physical and financial progress reports (every quarter).
- ix. Transfer funds to different entries/individuals shall be made through PFMS/ DBT mode, as applicable.

3. The Expenditure is debitable to the following Head of Account under Demand No. 56 of M/o Housing and Urban Affairs (MoHUA) for the financial year 2019-20after duly reappropriation from the respective Non-functional Head to the Functional Head for NE State:
