Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of July, 2023.

I. Swachh Bharat Mission

- i. All 4,715 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,355 cities have been certified through third party verification, 3,547 cities have been certified as ODF+, 1191 cities have been certified as ODF++ and 14 cities (Indore, Surat, New Delhi Municipal Council (NDMC), Tirupati, Chandigarh, Navi Mumbai, Vijayawada, Hyderabad, Greater Visakhapatnam, Karad, Panchgani, Bhopal, Baramati and Mysore) have been certified as Water+.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of “SBM Toilet”.
- iii. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- iv. The result of GFC 2022 was declared on 1st October 2022 as part of the Swachh Survekshan Award Ceremony 2022. The number of cities with 7-Star Certification is 1, 5-Star Certification is 11, 3-Star Certification is 199 and 1-Star Certification is 234 under Star Rating Protocol for Garbage Free Cities(GFC).
- v. A review-cum- workshop on the Planning and Implementation of SBM-U 2.0 was conducted on 10.07.2023. Hon’ble Minister of Housing and Urban Affairs (HUA) announced the launch of the Training Program at Centre of Excellence, Indore, Swachhata Knowledge Partners Directory & Swachh Survekshan 2024 Toolkit.
- vi. Honble Minister (HUA) launched the the Toolkit for the 9th edition of Swachh Survekshan (SS) – 2024 under Swachh Bharat Mission Urban 2.0 on 10th July, 2023. The Toolkit has specifically included indicators related to sanitation and waste management in schools, Swachhata from Mission LiFE and participation of SHGs (convergence with NULM) in the Waste Management eco-system . To control open urination in the cities, yellow spots has been added an indicator in SS 2024.

II. Smart Cities Mission (SCM)

- i. 8,023 projects worth ₹1,79,205 crore are ongoing, of which 5,975 projects worth ₹ 1,08,793 crore have already been completed.
- ii. 117 additional projects worth ₹ 1,110 crore have been completed during the month of July.
- iii. Freedom2WalkCycleRun Campaign was launched by Smart Cities Mission, MoHUA in collaboration with ITDP India. The F2WCR campaign is implemented every quarter for 45 days to promote walking, cycling, and running among city leaders in 100 smart cities and beyond. At present, Quarter 2 is ongoing which spans from **3rd June – 17th July 2023**. The second quarter was completed recently, which spanned 45 days and attracted over **130 participants, more than 25 cities across the nation recorded over 58,000 km of cycling, walking, and running**.
- iv. Smart Cities Mission launched the Streets4People and IndiaCycles4Change to reimagine streets as safe, happy, and healthy public spaces by opening up streets for people to cycle, walk, exercise, and socialize with friends.
- v. Smart Cities Mission organized 6-months long event Amrit Utsav: Connecting People to Smart Cities, from 1 January to 30 June 2023. However, the deadline for the **Amrit Utsav got extended till 31 July 2023**, when more cities participated and organized events. Till date, 100 Smart cities have organized 200+ online/ offline events on either one or more of the eight themes (i.e. Vocal for Local, Unity of the country (Unity by Tech), Sustainable Development, Atmanirbhar Bharat, Inclusive Development, Health & Wellness, Empowerment of Women & Children, Freedom Struggle , where more than 6,00,000 citizens proactively participated.
- vi. On 04 June 2023, The Urban Learning Internship Program (TULIP) successfully completed three years since its launch date. Under this program, over 10,000 internship opportunities have been provided across several ULBs till July 2023.
- vii. **NOTABLE PROGRESS IN THE MISSION**
 - Integrated Command & Control Centres (ICCCs) to help cities in evidence-based smart governance have been operationalized in **100 smart cities**.
 - Recognizing the need for collaborations/partnerships with the private sector to bring efficiencies **178 PPP projects have been completed** and **55 projects are in the pipeline** with investments worth **₹ 6,752** crore approximately.

- **1,055 vibrant public space** (river/lakefronts, parks and playgrounds, and tourism destinations) **projects are completed.**
- **1,149 WASH projects and 571 smart energy projects** have been completed for making cities more liveable and sustainable.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹83,149 crore exceeding approved action plan worth ₹ 77,640 crores. Some States have taken up projects in excess of their approved SAAPs, wherein excess amount will be borne by the States/ ULBs. Works have been completed for 5,001 projects worth ₹39,614 crores & works in progress for 891 projects worth ₹43,070 crore. In all, physical work worth about ₹72,770 crore has been carried out in completed/ ongoing AMRUT projects implying that around 94% of physical work has been completed.
- So far, ₹39,460 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under sub-schemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS) in 25 selected cities'.

IV. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)

- During the month of July of current financial year 8,657 Self Help Groups (SHGs) have been formed; 4,802 SHGs were given Revolving Fund; 9,867 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 14,848 no. of loans were given to SHGs under SHG-Bank linkage programme.

V. PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi)

- Under PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi), 69,77,483 applications have been received against which 54,39,685 sanctions and 51,45,848 disbursals have been made.
- A total of ₹ 9.432 crore have been released under the mission during the month of July, 2023.

VI. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. Since the inception, Mission has sanctioned 1.19 crore houses of which 112.30 lakh houses have been grounded for construction of which 76.02 lakh houses have been completed/ delivered.
- ii. ₹ 1,102.99 crore have been released under PMAY(U) during the month of July, 2023.

VII. Housing

- i. All States/UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 32 States/UTs have set up Real Estate Regulatory Authority (Regular - 27, Interim - 05). *Ladakh, Meghalaya and Sikkim have notified the rules while yet to establish Authority.*
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular - 24, Interim - 04) *(Arunachal Pradesh, Jammu & Kashmir, Ladakh, Meghalaya, Mizoram, Sikkim and West Bengal are under process to establish).*
- iv. Regulatory Authorities of 30 States/ UTs have operationalized their websites under the provisions of RERA. *(Arunachal Pradesh and Manipur are under process to operationalize).*
- v. 1,09,012 Real Estate Projects and 77,960 Real Estate Agents have registered under RERA across the country.
- vi. 1,11,374 Complaints have been disposed-off by the Real Estate Regulatory Authorities across the country. 156 projects and 96 agents have been registered during the month of July 2023.
