### Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of December, 2018

### I. Swachh Bharat Mission

- i. 2 cities/ towns were declared as Open Defecation free (ODF) during this month. A total of 4,125 cities/towns have been declared as ODF so far.
- ii. 1.37 crore citizens are registered on the Swachhata App; 1.54 crore complaints have been registered out of which 1.44 crore complaints have been resolved by end of this month.
- iii. The Public Toilet locating facility on Google Maps has been implemented in 1065 cities with 37,000 toilet blocks mapped so far.
- iv. Rs. 435.11 crore were released to the States during the month.
- v. From the months of August 2018, Ministry has been releasing Swachh Survekshan 2019 alerts on whatsapp groups, guiding the Urhan Local Bodies(ULBs) at every step for the 4 week long Survekshan. The process of information capturing has been made online in 2018 and 4,237 ULBs have filled their progress and completed city profile, whereas 4,227 ULBs have uploaded evidence based documents in support to their claims.
- vi. On Swachh Bharat Helpline (1969), for all issues related to Swachh Bharat, more than 4.5 Lakh calls have been answered with an average handling time of 1 minute 30 seconds.
- vii. National Institute of Urban Affairs (NIUA) has organised and conducted 20 exposure workshops in the various States/UTs on Solid Waste Management covering 383 ULBs with total of 868 municipal staffs trained to understand the Solid Waste Management Rules 2016.
- viii. 'Swachh Manch' is the citizen engagement platform where 81,504 events are posted, 99 lakh people participated and 2,226 ULBs are on board.
- ix. 10 Video Spots, 45 seconds each, for Swachh Survekshan 2019 started playing on Doordarshan, Doordarshan NEWS and Doordarshan regional subsidiaries from 30<sup>th</sup> December 2018. 10 Radio spots, 30 seconds each, for Swachh Survekshan 2019 started running on the regional private FM channels across the country.

x. Total 46 ULBs have been declared as ODF+ and 7 Cities have been declared as ODF++.

#### II. Smart Cities Mission

- i. Work was completed in 57 projects worth Rs. 690 crore, work was started for 176 projects worth Rs. 7,093 crore, tenders were issued for additional 53 projects worth Rs. 2,669 crore. With this, 2,628 projects worth Rs. 1,01,381 crore have been tendered, 1908 projects worth Rs. 59,649 crore are grounded and 582 projects worth Rs. 10,769 crore have been completed.
- ii.Rs. 1034 crore were released to the States.
- iii. 8 Project Management Consultants (PMCs) were appointed in Srinagar, Jammu, Silvassa, Aizwal, Shillong, Itanagar, Karavatti, New Town Kolkata, Shimla, thus taking the total tally of Smart cities with PMCs to 99.
- iv. The Smart City CEOs Meet on Smart Cities Standardization was organized in association with Bureau of Indian Standards (BIS) on 9<sup>th</sup> December 2018 to focus on various standardization initiatives to be adopted in smart cities.
- v. The Smart Cities Mission has initiated a research project titled "India Urban Data Exchange (IUDX)", an open source platform aimed at enabling cities to harness full potential of the enormous data being generated in Smart Cities. A MoU with Indian Institute of Science (IISc), Bangalore, has been signed in this regard.

#### III. HRIDAY

i. Rs. 34.83 crore was released for various projects under HRIDAY.

## IV. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

i. State Annual Action Plans (SAAPs) to the tune of Rs. 77,640 crorehave been finalized for all the States. Detailed project reports for projects costing Rs. 78,764 crore have been approved. 1,158 projects worth Rs. 2,670 crore have been completed, contracts have been awarded for 3,180 projects worth Rs. 53,864 crore and 647 projects worth Rs. 13,309 crore are under tendering and DPRs worth Rs. 8,922 crore are under preparation.

ii. Rs.16,954.53 crore has been released to States/UTs towards project implementation, Administrative & Office Expenses, Reform Incentive and for formulation of GIS based Master Plans.

## V. Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

- i. Rs. 4.15 crore has been released during the month.
- ii. 60,458 Self Help Groups (SHGs) were formed, 37,075 SHGs were given Revolving Fund, 2,04,831 candidates were skill trained, 1,02,022 trained candidates were given placement, 72,901 beneficiaries were assisted with loans for setting up of individual and micro enterprises, and 73,171 loans were given to SHGs under SHG-Bank linkage programme.

## VI. Pradan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)

- i. A total of Rs. 238.33 crore has been released during the month.
- ii. 68.86 lakh dwelling units in 14,424 projects with an investment of Rs. 3,87,433 crore involving Central assistance of Rs. 1,05,737 crore have been approved under PMAY. So far, 36,95,480 houses have been grounded for construction, 13,59,137 houses have already been constructed and 13,24,851 houses have been occupied.
- iii. Release of Central grant for the States of Andhra Pradesh, Gujarat, Karnataka, Maharashtra, Odisha and Uttar Pradesh was approved.

#### **VII. Urban Transport**

9.7 km long Lajpat Nagar – Mayur Vihar Pocket 1 Section of 59 km long Majlis Park – Shiv Vihar corridor (line 7) of Phase III of Delhi metro (also known as Pink Line) was inaugurated on 31.12.2018 for commercial operation.

### VIII. Housing Division

Fourth Regional Workshop (Eastern and North-Eastern Region) on Real Estate Regulation and Development Act (RERA) was held on 15.12.2018 in Ranchi.
