Sub: Release of Rs. 27.50 lakh to State Govt. of Chhattisgarh as advance amount of 1st installment of Central Assistance towards IEC activities for FY 2020-21 under Capacity Building activities of PMAY-U Mission - reg.

Sir,

I am directed to convey the sanction of the Component Authority for release of **Rs. 27,50,000/- (Rupees Twenty Seven Lakh and Fifty Thousand only)** to State Govt. of Chhattisgarh towards IEC activities under Capacity Building Activities of PMAY-U Mission for FY 2020-21. The details of the release are as under:

2. Earlier, fund of Rs. 27.50 lakh was released to State Govt. of Chhattisgarh as reimbursement of 2nd and final installment of Central Assistance for expenditure incurred towards IEC activities for FY 2019-20 under Capacity Building activities of PMAY-U Mission vide sanction letter of even number dated 22.06.2020 and therefore, no UC is pending for the said release.

3. The above grant is subject to the following conditions:

(i) All IEC activities are allowed except TV advertisements and News Paper advertisements. IEC activities are to be carried out in States based on pre-approved Government /DAVP rates. The agencies selected to perform the IEC activities should be empanelled with Government or should have sufficient prior experience of working with government. All expenditures will be reimbursed as per actual and based on cost norms against urban population in the State.

(ii) The bills and Vouchers regarding the expenditure incurred under IEC are to be examined and approved at the SLNA level by the competent authority as per State rule/as the case may apply (the bills/vouchers to be counter signed by the finance department) and an undertaking and claim of reimbursement to be submitted to the Ministry.

- (iii) A brief report highlighting assessment of impact by IEC activities is also required for re-imbusement. All bills voucher etc, should be safely kept at SLNA level for future audit and other references. All expenditure under this head is to be reimbursed.
- (iv) Remaining 50% of Central Assistance would be released as per actual and on receipt of Utilization Certificate along with Undertaking (in prescribed format mentioned in Capacity Building Activities - Norms, fund Disbursal processes and Plan Templates) from the State.
- (v) PMAY (U) promotion activities should have prominent display of PMAY logo and name. Prominence-of PMAY (U) in IEC materials should reflect in content, size, and in all other possible ways.
- (vi) The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- (vii) The State will utilize the sanctioned grant for the purpose for which it is released.
- (viii) The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- (ix) The amount of central assistance approved will form a part of capacity building plan of the State under PMAY (Urban).
- (x) When there is an element of cash transfer, the same may be made through DBT/EAT module of PFMS as applicable.

4. The amount is debitible from the account of the Central Government in the books under the following Head of Account under Demand No. 57 of Ministry of Housing and Urban Affairs for FY 2020-21:

As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/ Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act of 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.


