

Annexure

Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of April, 2023.

I. Swachh Bharat Mission

- i. All 4,715 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,355 cities have been certified through third party verification, 3,547 cities have been certified as ODF+, 1191 cities have been certified as ODF++ and 14 cities (Indore, Surat, New Delhi Municipal Council (NDMC), Tirupati, Chandigarh, Navi Mumbai, Vijayawada, Hyderabad, Greater Visakhapatnam, Karad, Panchgani, Bhopal, Baramati and Mysore) have been certified as Water+.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iii. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- iv. The result of GFC2022 was declared on 01st October 2022 as part of the Swachh Survekshan Award Ceremony 2022. The number of cities with 7-Star Certification is 1, 5-Star Certification is 11, 3-Star Certification is 199 and 1-Star Certification is 234 under Star Rating Protocol for Garbage Free Cities(GFC).
- v. Seventh meeting of the Project Steering Advisory Committee of UNIDO in partnership with MoHUA was held on the 13th April, 2023. The discussions revolved around designing carbo neutral and nature positive cities.

II. Smart Cities Mission (SCM)

- i. 7,857 projects worth ₹180,177 crore are ongoing, of which 5,713 projects worth ₹ 1,06,722 crore have already been completed. During the month 86 additional projects worth ₹ 337 crore have also been completed.
- ii. A Smart City Sub-Group Meeting was conducted on 19.04.2023 under the Japan-India Joint Working Group. The meeting was attended by industry partners from both the countries. From India, Tech Mahindra, Quantela, Wipro, L&T, and Fluentgrid attended the meeting. Companies with the Japanese delegation were Canon

Corporation, NEC Corporation, Panasonic Life Solutions India Pvt. Ltd.

- iii. 3rd Smart Cities CEOs conference on Data and Technology, Chandigarh was conducted on 27 April 2023 in Chandigarh to share the learnings of 100 smart cities on various topics like Use Case Operation Presentations by Cities, ICCC Maturity Assessment Framework (IMAF) Presentation by Cities and Business Plan Overview & Presentation by Cities.
- iv. Cycling tour of City Beautiful Chandigarh and Yoga Session were organized on 28th April 2023 for delegates from 100 Smart Cities across India came to participate in the Smart Cities CEOs Conference on Data and Technology.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. State Annual Action Plans(SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹83,368 crore. Progress in implementation of AMRUT: Detailed Project Reports (DPRs) have been approved for the projects costing ₹83,368 crore exceeding approved Action Plans worth ₹77,640 crore. Some States have taken up projects in excess of their approved SAAPs, wherein excess amount will be borne by the States/ULBs. Works have been completed for 4,910 projects worth ₹37,522 crore & work in progress for 987 projects worth ₹45,231 crore. In all, physical work worth about ₹70,901 crore has been carried out in completed/ongoing AMRUT projects implying that around 91% of physical work has been completed.
- ii. So far, ₹38,134 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under sub-schemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS) in 25 selected cities'.

IV. Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)

- i. During the month of April of current financial year 1,695 Self Help Groups (SHGs) have been formed; 1,880 SHGs were given Revolving Fund; 562 beneficiaries were assisted with loans for setting up of individual and micro enterprises and 1089 no. of loans were given to SHGs under SHG-Bank linkage programme.

V. PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi)

- i. Under PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi), 64,83,419 applications have been received against which 48,22,396 sanctions and 44,77,888 disbursals have been made.

- ii. A total of ₹3.18 Lakh have been released under the mission during the month of April, 2023.

VI. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. Since the inception, Mission has sanctioned 1.20 crore houses of which 110.20 lakh houses have been grounded for construction of which 73.61 lakh houses have been completed/delivered.

VII. Housing

- i. **All** States/UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. **32** States/UTs have set up Real Estate Regulatory Authority (Regular - 26, Interim - 06). *Ladakh, Meghalaya and Sikkim have notified the rules while yet to establish Authority.*
- iii. **28** States/UTs have set up Real Estate Appellate Tribunal (Regular - 24, Interim - 04) *(Arunachal Pradesh, Jammu & Kashmir, Ladakh, Meghalaya, Mizoram, Sikkim and West Bengal are under process to establish).*
- iv. Regulatory Authorities of **30** States/UTs have operationalized their websites under the provisions of RERA. *(Arunachal Pradesh and Manipur are under process to operationalize).*
- v. **1,02,985** Real Estate Projects and **72,662** Real Estate Agents have registered under RERA across the country.
- vi. **1,07,146** Complaints have been disposed-off by the Real Estate Regulatory Authorities across the country. 1387 projects and 293 agents have been registered during the month March 2023.
