ORDER

Subject: Constitution of 1st Fare Fixation Committee for Rapid MetroRail Gurgaon Ltd. (RMGL) under sections 33 and 34 of the Metro Railway (Operation and Maintenance) Act, 2002 (60 of 2002).


In exercise of the powers conferred under sections 33 and 34 of the 'Metro Railway (Operation and Maintenance) Act, 2002 (60 of 2002)', the Central Government hereby constitutes the following Fare Fixation Committee for the purpose of recommending to the Metro Railway Administration the fares for the carriage of passengers by the Metro Railway on the Rapid MetroRail Gurgaon network :

(i)	Justice (Retd). Dr. Bharat Bhushan Parsoon, Punjab & Haryana High Court	-	Chairman
(ii)	Shri K. Sanjay Murthy, Additional Secretary (D), Ministry of Housing and Urban Affairs, Government of India	-	Member
(iii)	Shri Depinder Singh Dhesi, Chief Secretary, Government of Haryana	-	Member

2. The Fare Fixation Committee shall submit its report and recommendations to the Rapid MetroRail Gurgaon Ltd. within a period not exceeding three months with effect from the date of assumption of charge for the post of Chairperson by Dr. Bharat Bhushan Parsoon, retired Judge of the Punjab & Haryana High Court.

3. The Fare Fixation Committee shall be governed by the relevant provisions of the Metro Railway (Operation and Maintenance) Act, 2002 (60 of 2002) and the Fare Fixation Committee (Salaries, Allowances and Other Terms and Conditions of Service of the Chairperson and Members) Rules, 2003 and the Fare Fixation Committee (Procedure) Rules, 2003 (copies enclosed).


