 - To promote the policy through an in-depth communication strategy to help facilitate translating the policy and reward scheme into action.
 - To review and monitor the progress/performance of states and city and address and attempt to smoothen the issues and bottlenecks that may arise during the implementation phase.
- 4. Expenses towards TA/DA etc. of the non-official members attending meetings shall be borne by the Ministry.
- 5. The Chairperson shall invite any other suitable expert if felt necessary.
