I am directed to convey the sanction of the Competent Authority to release an amount of Rs. 7,65,000/- (Rupees Seven Lakh and Sixty Five Thousand only) to UT Govt. of Dadra & Nagar Haveli as 1st instalment of Central Assistance for establishment of 1 State Level Technical Cell (SLTC) under PMAY – HFA (Urban) mission for the year 2017-18. Details are enclosed at Annexure:

- 2. The above grant is subject to the following conditions:
  - (i) The UT will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
  - (ii) The UT is requested to establish the SLTC at the earliest under intimation to this Ministry.
  - (iii) The UT will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.
  - (iv) Further instalment of funds for SLTC will be considered on receipt of expenditure statement/UC from the State Government along with details of specialists engaged subject to financial norms approved by 1st CSMC as well as adherence to scheme guidelines and submission of pending UCs under RAY, if any.
  - (v) If the existing Cell under RAY has been continued for PMAY (U) mission, the funds will be considered for release on receipt of expenditure statement and submission of pending UCs under RAY, if any.
  - (vi) UT Government is required to furnish Utilization Certificate as per GFR 2017 and Statement of Expenditure to the Government of India before claiming next instalment on utilization of 70% of the amount released earlier.
  - (vii) Release of 2<sup>nd</sup> instalment would be based on the UC as well as the actual remuneration paid to the professionals engaged in the SLTC, based on the man-months of services provided by them.
  - (viii) The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
  - (ix) The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.
  - (x) Transfer of funds to different entities/individuals shall be made through PFMS/DBT mode, as applicable.
