I am directed to convey the sanction of the President of India to release Central Assistance as 1st installment of **Rs. 68,06,500/- (Rs. Sixty Eight Lakh Six Thousand and Five Hundred only)** to the State Govt. of Gujarat towards IEC activities under Capacity Building Activities of PMAY-U Mission for the following:

Earlier, the fund of Rs. 40.00 lakh was released to State Govt. of Gujarat as 1<sup>st</sup> installment of Central Assistance for IEC activities for FY 2018-19 vide sanction letter of even no. dated 22.04.2019. State Govt. of Gujarat has submitted the Utilization Certificates (UCs) of Rs. 68.065 lakh for FY 2018-19.



- 3. The above grant is subject to the following conditions:
- (i) All IEC activities are allowed except TV advertisements and News Paper advertisements. IEC activities are to be carried out in States based on pre-approved Government /DAVP rates. The agencies selected to perform the IEC activities should be empanelled with Government or should have sufficient prior experience of working with government. All expenditures will be reimbursed as per actual and based on cost norms against urban population in the State.
- (ii) The bills and Vouchers regarding the expenditure incurred under IEC are to be examined and approved at the SLNA level by the competent authority as per State rule/as the case may apply (the bills/vouchers to be counter signed by the finance department) and an undertaking and claim of reimbursement to be submitted to the Ministry.
- (iii) A brief report highlighting assessment of impact by IEC activities is also required for re-imbursement. All bills voucher etc, should be safely kept at SLNA level for future audit and other references. All expenditure under this head is to be reimbursed.
- (iv) Remaining 50% of Central Assistance would be released as per actual and on receipt of Utilization Certificate along with Undertaking (in prescribed format mentioned in Capacity Building Activities Norms, fund Disbursal processes and Plan Templates) from the State.
- (v) PMAY (U) promotion activities should have prominent display of PMAY logo and name. Prominence-of PMAY (U) in IEC materials should reflect in content, size, and in all other possible ways.
- (vi) The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- (vii) The State will utilize the sanctioned grant for the purpose for which it is released.
- (viii) The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- (ix) The amount of central assistance approved will form a part of capacity building plan of the State under PMAY (Urban).
- (x) Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfers to individuals, the same may be made through PFMS/DBT mode, as applicable.
- 3. The amount is debitable from the account of the Central Government in the books under the following Head of Account under Demand No. 56 M/o Housing and Urban Affairs for the year 2019-20:
