**Sub: Release of Central Assistance under Pradhan Mantri Awas Yojana (PMAY) (Urban)-Housing for All Mission to State Govt. of Gujarat for the financial year 2018-19.**

Sir,

I am directed to convey the Sanction of the President of India to release an amount of **Rs. 40,000/- (Rupees Forty Thousand only)** as 1<sup>st</sup> instalment to the State Government of **Gujarat** as Central Grant for Creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY)-Housing for All (Urban) Mission for State's Annual Plan 2018-19 (Scheduled Tribe Component).

2. The fund being released is in proportion to data entered in MIS out of the approved list of beneficiaries in the CSMC in its 30th meeting held on 7th February, 2018. The remaining funds under 1<sup>st</sup> instalment will be released subsequently once data entry is completed and reported in MIS. The category-wise summary of the above said release is as under:



3. Based on the decision of CSMC under Pradhan Mantri Awas Yojana (Urban)-Housing for All (HFA) Mission in its 30<sup>th</sup> meeting held on 07<sup>th</sup> February, 2018 and on the recommendations made by MoHUA, the amount of central grant is being released subject to the following conditions:

- i. Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).

- ii. The State Government and implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- iii. The State Govt./Implementing agencies shall utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of PMAY (U).
- iv. The expenditure on the implementation of the scheme/projects will be shared between the Central and the State/ULB/Implementing Agency (IA) as committed. The committed State share should also be released within 15 days from the date of receipt of Central Share in the SLNA account. In case of shortfall of State/ULB/IA share, corresponding amount of Central share will be deducted from the subsequent instalment (s).
- v. The State Government shall ensure the geo-tagging of all houses approved under ISSR component of PMAY (U) and subsequent release by the State Government to the beneficiary should be made in 3-4 instalments depending on the progress/stage of construction of the house.
- vi. State Government shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Government / ULB.
- vii. State Government shall submit the Action Taken (ATR) on the observations/recommendations of Third Party Quality Monitoring Agency (TPQMA) for quality monitoring purpose before release of subsequent instalment.
- viii. The State Government shall provide funds as per approvals in the projects.
- ix. The State Government shall furnish the Utilization Certificates of the Grant released in the prescribed format (form 19 A) as per GFR-2017 and as provided in the scheme guidelines.
- x. The funds shall be utilized for the purpose for which these are sanctioned; otherwise these will have to be refunded along with interest as per provisions for GFR-2017.
- xi. Transfer of funds to different entries and individual beneficiaries, shall be made through PFMS/DBT mode, as applicable.

4. Release of the Grant may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest, as applicable, for the period of default.

5. The payment is adjustable in the account of the Central Government in the books under the following Head of Account under Demand No. 56 of M/o. Housing and Urban Affairs for the year 2018-2019:
