Subsequently, a pilot project on the implementation of benchmarking has been initiated in 28 cities in which JICA was an active partner. It is likely that the PIPs will include measures related to infrastructure up-gradation/creation which could be considered for programmatic assistance. MoUD attaches high level of importance to this project which aims to shift the focus from asset creation to delivery of outcomes. JICA may consider supporting implementing of ISIP and PIP in the 28 pilot cities.

The plans would include measures for infrastructure/up-gradation.
