The undersigned is directed to convey the Sanction of the President of India to the payment as $\mathbf{1}^{\text {st }}$ installment for 13 AHP projects for constructions of 9293 Houses amounting to Rs. 8,27,73,440/-(Rupees Eight Crore Twenty Seven Lakh Seventy Three Thousand Four Hundred Forty only) (after adjustment) to the State Government of Maharashtra as Central Assistance (Other than Scheduled Castes Component \& Scheduled Tribe Component) for Creation of Capital Assets under PMAYHousing for All (Urban) mission for financial year 2017-18.
2. The statement showing details of the 13 AHP projects against which the above amount stand sanctioned towards $1^{\text {st }}$ instalment of the Central Assistance is at Annexure-I.
3. There is an excess ACA available with the State Government in respect of 4 AMP projects \{(1 Virar ( 3969 DUs), 1 VIRAR ( 1012 DUs), 1 MAR( 1536 DUS) \& 1 MAR ( 660 DUs) $\}$ considered in the $8^{\text {th }}$ CSMC meeting held on 28.04 .2016 which are now treated as withdrawn for want of SLSMC ratification. The excess ACA of Rs. 41,21,40,560/(Rupees Forty One Crore Twenty One Lakh Forty Thousand Five Hundred and Sixty only) released under the Other than Scheduled Castes Component \& Scheduled Tribe Component is adjusted in this sanction order. Details of funds released under these four projects may be seen in the statement enclosed as Annexure-II.
4. Based on decision of CSMC in its $\mathbf{2 5}^{\text {th }}$ meeting held on $\mathbf{2 3}^{\text {rd }}$ August, 2017 and on the recommendations made by M/O HUA, the amount of central assistance is being released subject to adhering to the following conditions:
(i) Necessary sanctions/ approvals/ compliance required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
(ii) The State Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve its scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
(iii) The State Government/Implementing agency shall utilize the grant in accordance with the approved guidelines of PMAY(U) for the implementation of the Scheme.
(iv) The list of beneficiaries under these approved projects will be provided by the State Government prior to release of second installment.
(v) The State Government shall furnish the Utilization certificates of the Grant released for the PMAY-HFA (Urban) in the prescribed format as per GFR - 2017.
(vi) Where there is an element of cash transfer to individual beneficiaries, the same may be made through PFMS/DBT mode as applicable and necessary transaction details may be updated in MIS immediately after the disbursement. The State Government shall submit an authenticated certificate from the bank showing complete details of disbursement of funds to each beneficiary before release of subsequent instalment.
(vii) The State Government shall ensure the geo-tagging of all these projects approved under PMAY (U) for monitoring of progress of construction.
(viii) State Government shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Government / ULB.
5. The funds may be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest, as applicable, for the period of default.
6. The payment are adjustable in the account of the Central Government in the books under the following Head of Account under Demand No. 56 of Ministry of Housing and Urban Poverty Alleviation for the year 2017-18:-
