Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of June, 2023.

I. Swachh Bharat Mission

- i. All 4,715 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,355 cities have been certified through third party verification, 3,547 cities have been certified as ODF+, 1191 cities have been certified as ODF++ and 14 cities (Indore, Surat, New Delhi Municipal Council (NDMC), Tirupati, Chandigarh, Navi Mumbai, Vijayawada, Hyderabad, Greater Visakhapatnam, Karad, Panchgani, Bhopal, Baramati and Mysore) have been certified as Water+.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iii. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- iv. The result of GFC 2022 was declared on 01st October 2022 as part of the Swachh Survekshan Award Ceremony 2022. The number of cities with 7-Star Certification is 1, 5-Star Certification is 11, 3-Star Certification is 199 and 1-Star Certification is 234 under Star Rating Protocol for Garbage Free Cities(GFC).
- v. Secretary, HUA has taken a review meeting for Bio-CNG on 09.06.2023.
- vi. National Advisory and Review Committee (NARC) was held on 8th June, 2023 under the chairmanship of Secretary MoHUA for approval of proposals for setting up solid waste processing facilities, used water management, capacity building and IEC of 9 states in which Action plans worth Rs. 2,450 were approved.
- vii. National Consultative Workshop on Used Water Faecal Sludge Management Systems was held in collaboration with UNICEF at Raipur, Chhattisgarh between 15th and 16th June, 2023.
- viii. Secretary, HUA launched the field assessment of Swachh Survekshan 2023.
- ix. A national workshop was held on 27.06.2023 28.06.2023 on Implementation of CBG Plants in Indore with the collaboration with GIZ for experience sharing and learning on CBG Plants

II. Smart Cities Mission (SCM)

- i. 7,973 projects worth ₹1,79,165 crore are ongoing, of which 5,858 projects worth ₹1,07,683 crore have already been completed.
- ii. 85 additional project worth ₹ 766 crore have been completed during the month.
- iii. 'Freedom2WalkCycleRun' Campaign was launched by Smart Cities Mission, MoHUA in collaboration with ITDP India. The F2WCR campaign is implemented every quarter for 45 days to promote walking, cycling, and running among city leaders in 100 smart cities and beyond.
- iv. On 25 June 2023, Smart Cities Mission embraced the vibrant celebration of the 8th anniversary of the Mission. The event witnessed active participation from all 100 cities, with enthusiastic engagement from citizens being duly captured. ten thematic videos were released on the official YouTube channel of Smart Cities Mission, narrating the impactful people-centric stories of Smart Cities Mission.www.youtube.com/@SmartCitiesMission.
- v. Till date, 100 Smart cities have organized 150+ online/ offline events on either one or more of the eight themes (i.e. Vocal for Local, Unity of the country (Unity by Tech), Sustainable Development, Atmanirbhar Bharat, Inclusive Development, Health & Wellness, Empowerment of Women & Children, Freedom Struggle, where more than 5,00,000 citizens proactively participated.
- vi. On **04 June 2023**, The Urban Learning Internship Program (TULIP) successfully completed three years since its launch date. Under this program, over 8,500 internship opportunities have been provided across several ULBs.

vii. NOTABLE PROGRESS IN THE MISSION

- <u>Vibrant Public Spaces:</u> More than 1,027 parks, green spaces, and lakefront/riverfront promenades developed, 180 waterfront projects across 47 cities.
- <u>Economic Hubs</u>: 15 incubation centers/skill development centers developed and over 200+ market redevelopment projects completed.
- <u>Mobility:</u> More than 2,500+ kms of smart roads are constructed/improved and 573 km of cycle tracks are developed.
- <u>Streetlights:</u> More than 17.36 Lakhs LED/Solar Streetlights installed and over 8,175 kms of underground electricity cabling constructed.

Technology used in cities

- **Solid Waste Management**: 80+ cities monitoring SWM through ICCC. More than 2+ Lakh RFID enabled **e-Waste Dustbins** installed.
- **Water Supply**: 347 projects across 93 cities, 25+ cities are monitoring water supply pipelines through SCADA system.
- **Education**: 6,800+ smart classrooms have been developed, 1600 Anganwadis and 40 cities have developed Digital Libraries.
- Health: 308 e-health centers and clinics have been developed (without dedicated beds), 480 Smart ambulances added and 255 numbers of health ATMs installed.
- **WiFi & Surveillance**: 9,732 WiFi hotspot locations were created and 76,000 CCTV cameras were installed.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹83,137 crore exceeding approved action plan worth ₹77,640 crores. Some States have taken up projects in excess of their approved SAAPs, wherein excess amount will be borne by the States/ ULBs. Works have been completed for 4,967 projects worth ₹38,645 crores & works in progress for 921 projects worth ₹43,992 crore. In all, physical work worth about ₹72,304 crore has been carried out in completed/ ongoing AMRUT projects implying that around 93% of physical work has been completed.
- ii. So far, ₹38,469 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under sub-schemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS) in 25 selected cities'.

IV. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)

i. During the month of June of current financial year 8,544 Self Help Groups (SHGs) have been formed; 3,234 SHGs were given Revolving Fund; beneficiaries were assisted with loans for setting up of individual and micro enterprises and 10,654 no. of loans were given to SHGs under SHG-Bank linkage programme.

V. PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi)

i. Under PM Street Vendor's Atma Nirbhar Nidhi (PMSVANidhi), 66,80,171 applications have been received against which 50,99,773 sanctions and 48,55,998 disbursals have been made.

ii. A total of ₹ 3.609 crore have been released under the mission during the month of June, 2023.

VI. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. Since the inception, Mission has sanctioned 1.19 crore houses of which 112.12 lakh houses have been grounded for construction of which 75.22 lakh houses have been completed/delivered.
- ii. ₹ 948.84 crore have been released under PMAY(U) during the month of June, 2023.

VII. Housing

- i. All States/UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 32 States/UTs have set up Real Estate Regulatory Authority (Regular 27, Interim 05). Ladakh, Meghalaya and Sikkim have notified the rules while yet to establish Authority.
- iii. 28 States/UTs have set up Real Estate Appellate Tribunal (Regular 24, Interim 04) (Arunachal Pradesh, Jammu & Kashmir, Ladakh, Meghalaya, Mizoram, Sikkim and West Bengal are under process to establish).
- iv. Regulatory Authorities of 30 States/ UTs have operationalized their websites under the provisions of RERA. (Arunachal Pradesh and Manipur are under process to operationalize).
- v. 1,08,856 Real Estate Projects and 77,864 Real Estate Agents have registered under RERA across the country.
- vi. 1,11,302 Complaints have been disposed-off by the Real Estate Regulatory Authorities across the country. 1,545 projects and 879 agents have been registered during the month.
