



## Monthly Summary on the principal activities of Ministry of Housing and Urban Affairs for the month of April, 2019

### I. Swachh Bharat Mission

- i. 1.50 crore citizens are registered on the Swachhata App, 1.70 crore complaints have been registered out of which 90 % complaints have been resolved by the end of this month.
- ii. Rs. 39.87 crore has been released to the States during the month.
- iii. On Swachh Bharat Helpline (1969), for all issues related to Swachh Bharat, more than 4.7 Lakh calls have been answered with an average handling time of 1 minute 30 seconds.
- iv. 'Swachh Manch' is the citizen engagement platform where 1,03,054 events are posted, 2 crore people participated and 2,430 ULBs are on board.
- v. More than 45,000 toilet blocks across 1,700 cities are live on Google Maps with the name of "SBM Toilet".

### II. Smart Cities Mission

- i. Work had been completed in 22 projects worth Rs. 176 crore, work was started for 8 projects worth Rs. 212 crore. With this, 862 projects worth Rs. 14,472 crore have been completed, 1,885 projects worth Rs. 72,680 crore are currently under implementation and 747 projects worth Rs. 44,909 crore are under tendering.
- ii. **Climate Smart Cities Assessment Framework:** Ministry in collaboration with GIZ and NIUA conducted Four Cluster workshops to engage on various aspects of the framework with all stakeholders to broaden the understanding about the framework and to discuss key next steps towards effective action for improving climate resilience and sustainability in our cities. The workshop was organized on 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup> & 15<sup>th</sup> April, 2019 at India Habitat Centre in New Delhi. Each city will have to appoint a Nodal Officer for the framework and two officials to represent Planning/ Waste Management/ Transport/ Water and Wastewater Management.
- iii. Telangana-Hub, Smart Cities Mission of Government of India and Atal Innovation Mission (AIM), NITI Aayog, hosted Smart City Arcade, a consultative session with Smart City startups seeking to engage with India's Smart Cities. This event helped corporate and government organizations to explore emerging Indian Smart City technologies pitched and showcased at T-Hub premises.

### **III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)**

i. State Annual Action Plans (SAAPs) to the tune of Rs. 77,640 crore have been finalized for all the States. Detailed project reports for projects costing Rs. 79,763 crore have been approved. 1,495 projects worth Rs. 3,629 crore have been completed, contracts have been awarded for 3,376 projects worth Rs. 59,185 crore and 355 projects worth Rs. 10,019 crore are under tendering and DPRs worth Rs. 8,664 crore are under preparation.

ii. So far, Rs.18,839.65 crore has been released to States/UTs towards project implementation, Administrative & Office Expenses, Reform Incentive and for formulation of GIS based Master Plans.

### **IV Deendayal Antyodaya Yojana / National Urban Livelihood Mission (DAY/NULM)**

i. 1,732 Self Help Groups (SHGs) were formed, 688 SHGs were given Revolving Fund, 4,567 candidates were skill trained and certified, 4,027 trained candidates were given placement, 1,223 beneficiaries were assisted with loans for setting up of individual and micro enterprises, and 1,505 loans were given to SHGs under SHG-Bank linkage programme.

### **V. Pradhan Mantri Awas Yojana (PMAY)/ Housing for All (HFA)**

i. Rs. 192.94 crore has been released during the month.

ii. 80.38 lakh dwelling units in 16,512 projects with an investment of Rs. 4,69,614 crore involving Central assistance of Rs. 1,24,652 crore have been approved under PMAY from June, 2015. So far, 45,44,982 houses have been grounded for construction, 25,05,441 houses have already been constructed and 22,91,639 houses have been occupied.

### **VI. International Cooperation**

i. Memorandum of Understanding (MoU) between the Government of Republic of India and the Government of Kingdom of Saudi Arabia for cooperation in the field of Housing was signed on 20.02.2019.

ii. A Memorandum of Understanding (MoU) between the Ministry of Housing & Urban Affairs (MoHUA), Government of Republic of India and the Ministry of National Planning, Urban Planning, Housing and City Policy, Government of Kingdom of Morocco to promote exchange of information and technical co-operation in the field of Housing & Human Settlement was signed on 18.02.2019.

## **VII. NBCC(India)**

i. NBCC signed a MoU with the Government of Mauritius to undertake construction of 3 projects in Mauritius – Police Academy, Forensic Science Laboratory and National Archives & National Library.
