Monthly summary on the principal activities of Ministry of Housing and Urban Affairs for the month of May, 2022

I. Swachh Bharat Mission

- i. 4,371 cities/ towns have been declared as ODF (Open Defecation Free) of which 4,317 cities have been certified through third party verification, 3,354 cities have been certified as ODF+, 964 cities have been certified as ODF++ and 9 cities have been certified as Water+. A Consultative meeting was held on 28thApril, 2022 for revising the ODF, ODF+, ODF++ and Water+ protocols with all States/ ULBs and Sector Partners.
- ii. 67,407 toilets across more than 3,326 cities are live on Google Maps with the name of "SBM Toilet".
- iii. Swachhata App emerged as an important tool towards enabling citizens to have their grievances addressed by the concerned Municipal Corporation. The revised version enables citizens to get their COVID-related complaints also redressed by their respective ULBs. The Swachhata App has a total of 2.08 crore users, who have posted 2.55 crore complaints, of which 2.39 crore complaints have been resolved, with a resolution of above 94%.
- iv. The Secretary, Ministry of Housing and Urban Affairs (MoHUA), launched the eighth edition of Swachh Survekshan (SS) SS 2023 under Swachh Bharat Mission Urban 2.0, in a virtual event on 24th May 2022.
- v. A meeting was held on 6th May 2022 under the chairmanship of Secretary (HUA) to review the progress achieved by cities in transitioning towards mechanical desludging of septic tanks & sewers.
- vi. The first Project Steering Committee (PSC) meeting for MoHUA-UNDP Plastic Waste Management (PWM) programme was held on May 4, 2022. In the meeting, two significant components for achieving the objectives of SBM 2.0 were highlighted. The first component is sustaining the outcomes achieved in SBM 1.0. The second would be ensuring Garbage Free Cities. The achievement of the goals of SBM 2.0 would include effective and sustainable management of waste, behaviour change pertaining to source segregation coupled with efficient door-to-door collection, operationalizing material recovery facilities (MRF) in each city, and the right technology to ensure optimum capacity utilization of MRFs.

II. Smart Cities Mission (SCM)

i. During the month 65 projects worth ₹ 1,498 crore have been completed, work has been started on 9 projects worth ₹ 90 crore. So far 7,638 projects worth ₹1,80,802 crore have been grounded and 3,914 projects worth ₹ 64,401 crore have been completed.

- ii. Government of Uttar Pradesh and MoHUA signed a Memorandum of Understanding (MoU) for implementation of National Urban Digital Mission (NUDM) in the State. Under NUDM, MoHUA shall support Government of Uttar Pradesh in digitalisation & standardization of urban services across all the ULBs of the State. MoHUA shall also support in developing State level and City level dashboards and other capacity building measures to successfully implement urban services through NUDM. In addition, through TULIP-The Urban Learning Internship program launched by the Government of India and Ministry of Education in June, 2020, the State Government of Uttar Pradesh would also committed to provide internship opportunities to students in Urban Local Bodies and other parastatals of the State.
- iii. Karnataka Government officially launched TULIP across all the 280 ULBs in the State in an event held on 27th May 2022. Shri Kunal Kumar, Joint Secretary and Mission Director, Smart Cities Mission, MoHUA made the opening remarks and spoke about the importance of creating an urban ecosystem that encourages fresh ideas and innovation for reimagining urban transformation.

III. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

- i. State Annual Action Plans (SAAPs) have been finalized for all the states for ₹77,640 crore. As on date, Detailed Project Reports (DPRs) have been approved for the projects costing ₹82,392 crore. Some States have taken up projects in excess of their approved SAAPs. Entire excess amount in such cases will be borne by the States/ULBs. Works have been completed for 4,281 projects worth ₹28,407 crore and work is in progress for 1,574 projects worth ₹53,265 crore. In all, physical work worth about ₹62,691 crore has been carried out in completed/ongoing AMRUT projects implying that around 81% of physical work has been completed.
- ii. So far, ₹37,488 crore has been released to States/UTs towards project implementation (including the eligible projects of erstwhile JnNURM), Administrative & Office Expenses (A&OE), reform incentive, and under subschemes on 'Formulation of GIS based Master Plans in AMRUT cities' and 'Local Area Plan (LAP) and Town Planning Schemes (TPS)' in 25 selected cities.
- iii. An online workshop on "Jal Shakti Abhiyan: Catch the Rain" campaign and mission "Amrit Sarovar" was organized by MoHUA on 30th May 2022.

IV. Deendayal Antyodaya Yojana /National Urban Livelihood Mission (DAY/NULM)

i. 8,906 Self Help Groups (SHGs) have been formed; 6,411 SHGs were given Revolving Fund; 11,527 candidates were skill trained and certified; 1467 trained candidates were given placement; 6,596 beneficiaries were assisted with loans

- for setting up of individual and micro enterprises and 5,710 loans were given to SHGs under SHG-Bank linkage programme.
- ii. Under PM Street Vendor's AtmaNirbhar Nidhi (PMSVANidhi), 48,71,607 applications have been received against which 35,04,764 sanctions and 32,32,300 disbursals have been made.

V. Pradan Mantri Awas Yojana (PMAY)/Housing for All (HFA)

- i. A total of ₹ 450.14 crores have been released under PMAY(Urban) 'Housing for All' mission during the month.
- ii. Since the inception, Mission has sanctioned 1.23 crore houses of which 100.16 lakh houses have been grounded for construction of which 60.17 lakh houses have been completed/delivered.

VI. Housing.

- i. All States/ UTs have notified rules under RERA except Nagaland, which is under process to notify the rules.
- ii. 31 States/UTs have set up Real Estate Regulatory Authority (Regular 25, Interim 06). Ladakh, Meghalaya, Sikkim & West Bengal have notified the rules while yet to establish authority.
- 28 States/UTs have set up Real Estate Appellate Tribunal (Regular -24, Interim 04).
- iv. Regulatory Authorities of 28 States/UTs have operationalized their websites under the provisions of RERA.
- v. So far, 92,418 complaints (including 1,808 complaints during the month) have been disposed of by the Real Estate Regulatory Authorities across the country
- vi. So far, 82,561 projects and 63,522 agents have been registered under RERA. 2,271 projects and 1,060 agents have been registered during the month.
